as under:

1. I am the Secretary of the Election Commission of India and as
such am well acquainted with the facts and circumstances of the
case and competent to affirm the present Counter Affidavit on
behalf of Respondent No. 3 (hereinafter known as "the
Answering Respondent") to the I.A. No. 183625 of 2019
(Application for Stay) filed by the Petitioners.
2. I state that I have read and understood the contents of the
aforementioned I.A. No. 183625 of 2019 (Application for Stay)
and the reply thereto is as under.

3. At the outset, I deny all the averments, submissions, contentions as well as the allegations contained in the aforementioned I.A. No. 183625 of 2019 (Application for Stay) to the extent they relate to the Answering Respondent, save and except those that are expressly and specifically admitted hereinafter.
4. The Answering Respondent submits that the aforementioned I.A. No. 183625 of 2019 (Application for Stay) has been filed by the Petitioners, seeking a stay on the Electoral Bond Scheme 2018, notified by the Central Government vide Notification dated 02.01.2018.
5. It is further submitted that the Answering Respondent's position in respect of the subject matter of electoral bonds has already been specified in its Counter Affidavit dated 27.03.2019, filed in the above W.P. (C) No. 880 of 2017, as well as in the Order dated 12.04.2019 passed by this Hon'ble Court in the said W.P. (C) No. 880 of 2017 (and other connected matters). It is, thus, prayed that the contents of the same may be read as part and parcel of the present Counter Affidavit on behalf of the Answering Respondent to the I.A. No. 183625 of 2019 (Application for Stay) filed by the Petitioners.
6. It is submitted that this Hon'ble Court, by its Order dated 12.04.2019 passed in W.P. (C) No. 880 of 2017 (and other connected matters), directed that:
- "13. In the above perspective, according to us, the just and proper interim direction would be to require all the political parties who have received donations through Electoral Bonds to submit to the Election Commission of India in sealed cover,*

detailed particulars of the donors as against the each Bond; the amount of each such bond and the full particulars of the credit received against each bond, namely, the particulars of the bank account to which the amount has been credited and the date of each such credit.

14. The above details will be furnished forthwith in respect of Electoral Bonds received by a political party till date. The details of such other bonds that may be received by such a political party upto the date fixed for issuing such bonds as per the Note of the Ministry of Finance dated 28.2.2019, i.e. 15.5.2019 will be submitted on or before 30th May, 2019. The sealed covers will remain in the custody of the Election Commission of India and will abide by such orders as may be passed by the Court."

7. Pursuant to the same, the Election Commission of India (i.e. the Answering Respondent herein) has received sealed covers from various political parties (National, State & Registered Unrecognized Parties), a list of which is being annexed herewith. True copy of List showing Status of filing of Electoral Bond details by Political Parties in sealed cover as per direction of this Hon'ble Court is annexed herewith and marked as **ANNEXURE-C/1** at Pages to .
8. It is further submitted that insofar as the issue of submission of annual audited reports by the political parties to the Election Commission of India is concerned, a list showing the current status of submission of Audited Annual Accounts of the political parties is being annexed herewith.




