## Analysis of Donations Received above Rs 20,000 by National Political Parties, FY 2024-25

This report, prepared by **Association for Democratic Reforms (ADR)**, focuses on donations above Rs 20,000, received by the National political parties during the financial year 2024-25, as per details submitted by the parties to the Election Commission of India (ECI). The National parties include Bharatiya Janata Party (**BJP**), Indian National Congress (**INC**), Bahujan Samaj Party (**BSP**), Aam Aadmi Party (**AAP**), Communist Party of India (Marxist) (**CPI(M)**) and National People’s Party (**NPEP**).

### Executive Summary

The **executive summary** below lists the key observations drawn from the report:

#### 1. Status of Submission of Contribution Reports of National Parties, FY 2024-25


- a) The **due date** for submission of contribution reports for the parties was **30 September 2025**.
- b) Only **BSP, NPEP** and **AAP** submitted their contribution reports on time while **INC, CPI(M)** and **BJP** submitted after a delay of 23 days, 66 days and 68 days respectively.

#### 2. Donations above Rs 20,000 to National Parties from all over India, FY 2024-25

- a) The **total donations** (above Rs 20,000) declared by the National parties for FY 2024-25 was **Rs 6648.563 cr** from **11,343 donations**.
- b) A total of **Rs 6074.015 cr** from 5522 donations was declared by **BJP** followed by **Rs 517.394 cr** from 2501 donations declared by **INC**. The **donations declared by BJP** are **more than ten times the aggregate declared by INC, AAP, CPI(M)** and **NPEP** for the same period.
- c) **BSP** declared that the party **did not receive any donations above Rs 20,000** during FY 2024-25, as it has been **declaring for the past 19 years**.


No. and amount of contributions (Above Rs 20,000) declared by National Parties, FY 2024-25 (in Rs Cr)



**3. Comparison of donations received by National parties during FY 2023-24 and FY 2024-25**

- The **total donations** of the National parties during FY 2024-25 **increased by Rs 4104.285 cr, an increase of 161%** from the previous financial year 2023-24.
- Donations to the **BJP** increased from **Rs 2,243.947 cr** in FY 2023-24 to **Rs 6074.015 cr** in FY 2024-25, marking a **171%** increase. Similarly, donations to the **INC** rose from **Rs 281.48 cr** in FY 2023-24 to **Rs 517.394 cr** in FY 2024-25, reflecting an **84%** increase.
- In comparison to the previous financial year, donations declared by **AAP** increased by **244%** or **Rs 27.044 cr**, while donations declared by **NPEP** increased by **1313%** or **Rs 1.943 cr**.


Comparison of contributions (above Rs 20,000) to National Parties for FY 2023-24 and FY 2024-25 (in Rs Cr)



**4. State-wise donations to National Parties, FY 2024-25**

- Segregation of donations according to state** was made by ADR based on the **addresses** provided by the parties in their donations report to the ECI.
- A total of **Rs 2639.481 cr** was donated to the National Parties from **Delhi**, followed by **Rs 2438.86 cr** from **Maharashtra** and **Rs 309.177 cr** from **Gujarat**.
- Total donation of **Rs 55,000** from 3 donations from **United States (USA)** has been made to **AAP**.
- A total of **Rs 7.684 cr** (0.115% of total donations received by the National parties, FY 2024-25) could not be attributed to any State/ Union Territory due to **incomplete/undeclared information** provided by the parties.


**Top 5 states which contributed to National Parties, FY 2024-25


**5. Donors from corporates/business sectors Vs. individual donors**

- a) **3244 donations** to the National parties were made by **corporate/business sectors** amounting to **Rs 6128.787 cr (92.18%** of total donations) while **7900 individual** donors donated **Rs 505.66 cr (7.61%** of total donations) to the parties during FY 2024-25.
- b) **2794 donations from corporate/business sectors** were made to **BJP (Rs 5717.167 cr)** while **2627 individual** donors donated **Rs 345.94 cr** to the party during FY 2024-25.
- c) **INC** received a total of **Rs 383.8605 cr** via **112 donations** from **corporate/business sectors** and **Rs 132.3885 cr** via **2357 individual donors** during FY 2024-25.
- d) **BJP (Rs 5717.167 cr)** received **more than thirteen times** the total amount (Rs 411.62 cr) of **corporate donations** declared by all other National parties for the FY 2024-25.



## 6. Top donors to National Parties, FY 2024-25

- a) **Prudent Electoral Trust** donated a total of **Rs 2413.465 cr** to **BJP, INC** and **AAP** together and is the top donor to parties that received the maximum donations. The Trust donated **Rs 2180.7119 cr** to **BJP** (35.90% of total funds received by the party), **Rs 216.335 cr** to **INC** (41.81% of total funds received by the party) and **Rs 16.4178 cr** to **AAP** (43.08% of total funds received by the party).
- b) **Progressive Electoral Trust** donated **Rs 834.97 cr** from 2 donations, **AB General Electoral Trust** donated **Rs 621 cr** through 16 donations, **New Democratic Electoral Trust** donated **Rs 155 cr** through 7 donations to **BJP** and **INC**.
- c) **Serum Institute of India Pvt Ltd** donated **Rs 100 cr** through 3 donations, and **Rungta Sons Private Limited** donated **Rs 95 cr** through 4 donations to **BJP** in FY 2024-25

## Observations and Recommendations of ADR

### Observations

1. **INC, CPI(M)** and **BJP** submitted their contribution reports after a delay of 23 days, 66 days and 68 days, respectively.
2. 4 National parties, **BJP, INC, NPEP** and **CPI(M)** had not declared **PAN details of 205 donations** through which the parties collected a total of **Rs 3.468 cr (0.052%** of the total donations declared by National parties).
3. 3 National Parties (**CPI(M)**- Rs 23.90 lakhs, **BJP**-Rs 8.40 lakhs and **INC**- Rs 6.50 lakhs) have declared **Rs 38.80 lakhs from 33 donations having missing/incorrect PAN details**.
4. **BJP** declared 1656 donations of Rs 224.652 cr, **INC** collected 515 donations worth **Rs 419.474 cr**, **AAP** collected 549 donations of Rs 31.058 cr, **CPI(M)** collected 303 donations of Rs 8.312 cr and **NPEP** collected 17 donations of Rs 1.391 cr having **incomplete cheque/DD details** where cheque number, bank details on which it was drawn and the date on which the cheque was received/encashed is not provided. Thus, without

the complete cheque/DD details, it would be a time-consuming process to link the donors against their donations and hence, trace the money trail.

5. As done for the **last 19 years**, **BSP has declared again that the party did not receive any donations above Rs 20,000.**

## Recommendations

1. The Supreme Court gave a judgment on September 13, 2013 declaring that no part of a candidate's affidavit should be left blank. Similarly, **no part of the Form 24A submitted by political parties providing details of donations above Rs 20,000 should be blank.**
2. All donors who have donated a **minimum of Rs 20,000** as a single or multiple donations should **provide their PAN details.**
3. Introducing a provision where in **individual or a company cannot contribute multiple small donations exceeding a total of Rs 20,000 in a financial year**, so that parties are not able to bypass the reporting requirement despite receiving a larger overall sum from the same donor.
4. The National parties should, ideally, lead by example by filing complete and correct statements of donations to the ECI well in time for public scrutiny so as to encourage financial transparency.
5. It is suggested that the **ECI publicize on its website details of the action taken (if any) against political parties that fail to provide required details** (such as name, address, PAN and mode of payment) of individuals, companies or entities making donations in cash.
6. **Incomplete contributions reports** having missing or incorrect PAN/mode of payment details must **be returned to the parties** by the ECI, to deter them from providing incomplete information.
7. **The National and Regional political parties must provide all information on their finances under the Right to Information Act.** This will go a long way in strengthening political parties, elections and democracy.
8. **Annual scrutiny** of donations reports of **National, Regional and unrecognized parties** should be initiated by a dedicated department of the **CBDT**, to **discourage donations from shell companies or illegal entities.**
9. Reporting and disclosure procedures must be strengthened to ensure that financial reports are audited independently and made publicly available in a timely manner. The **development of an online reporting and disclosure platform** can improve efficiency and transparency. Provide **status updates on the submission of party reports** showing which all registered parties submitted on time, which delayed their submission and those which defaulted, including the action taken against such parties by the Commission or other relevant authority.
10. **Corporations should make details of their political contributions available in the public domain** through their websites (in annual reports or on a dedicated page) for increasing transparency in political financing.

## Detailed Report

Political parties rely heavily on donations for contesting elections and running their daily affairs. They receive huge sums of money in the form of donations/contributions from corporates or business houses, trusts and individuals. Section 29C of the Representation of People Act, 1951 mandates that political parties submit their contribution details in excess of Rs 20,000 received from any person or a company to the ECI annually, in order to enjoy 100% tax exemption.


This report, prepared by **Association for Democratic Reforms (ADR)**, focuses on donations above Rs 20,000, received by the National political parties during the financial year 2024-25, as per details submitted by the parties to the Election Commission of India (ECI). The National parties include Bharatiya Janata Party (**BJP**), Indian National Congress (**INC**), Bahujan Samaj Party (**BSP**), Aam Aadmi Party (**AAP**), Communist Party of India (Marxist) (**CPI(M)**) and National People's Party (**NPEP**).

### I. Donations above Rs 20,000 to National Parties from all over India (FY 2024-25)

- a) The total amount of donations received above Rs 20,000 by National political parties during FY 2024-25 is calculated from the donations report submitted to the Election Commission annually.
- b) The total amount of donations above Rs 20,000 declared by the National Parties was **Rs 6648.563 cr**, from **11,343 donations**, which amounts to an average of **Rs 58.61 lakhs per donation**.
- c) With regard to the total number of donations, **BJP leads with 5522 donations** from individuals and corporates while **AAP** declared a total of **2554 donations** followed by **INC** with **2501 donations**, **CPI(M)** with **741** donations and **NPEP** with **25** donations.
- d) A total of **Rs 6074.015 cr** was declared by **BJP** during FY 2024-25 while **INC** declared receiving **Rs 517.394 cr** during the same period.
- e) The **donations** declared by **BJP** are **more than 10 times the aggregate** declared by the INC, AAP, CPI(M) and NPEP for the same period (Rs 6074.015 cr declared by BJP against Rs 574.548 cr declared by the **remaining parties**).
- f) **BJP** received an average of **Rs 109.99 lakhs** per donation; **INC**– **Rs 20.68 lakhs** per donation, **NPEP** – **Rs 8.36 lakhs** per donation, **CPI(M)**– **Rs 2.28 lakhs** per donation and **AAP** – **Rs 1.49 lakhs** per donation.
- g) **BSP** declared that the party **did not receive any donations above Rs 20,000** during FY 2024-25, as it has been declaring for the past 19 years.

**No. and amount of contributions (Above Rs 20,000) declared by National Parties, FY 2024-25 (in Rs Cr)**




**II. Comparison of donations received by National Parties between FY 2023-24 and FY 2024-25**

- a) The **total donations** of the **National Parties** during FY 2024-25 increased by **Rs 4104.285 cr**, an increase of **161%**, from the previous financial year, 2024-25.
- b) Donations to **BJP** increased from **Rs 2243.947 cr** during FY 2023-24 to **Rs 6074.015 cr** during FY 2024-25 (**171% increase**) while donations to **INC** increased from **Rs 281.48 cr** during FY 2023-24 to **Rs 517.394 cr** during FY 2024-25 (**84% increase**).
- c) **NPEP** declared the **highest amounts increase of 1313%**, from **Rs 14.80 lakhs** in FY 2023-24 to **Rs 2.091 cr** in FY 2024-25 while **AAP** has declared an **increase of 244%**, from **Rs 11.062 cr** in FY 2023-24 to **Rs 38.106 cr** in FY 2024-25.


**Comparison of contributions (above Rs 20,000) to National Parties for FY 2023-24 and FY 2024-25 (in Rs Cr)**



**III. Mode of Contribution to National Parties, FY 2024-25**

- National Parties declared receiving a total of **Rs 5533.001 cr** by cheque/DD from **5164 donations** and formed **83.22%** of the total donations received.
- It is to be noted that **3040 donations** of a total of **Rs 684.887 cr** or **10.30%** of all donations contained incomplete cheque/DD details while **296 donations**, amounting to **Rs 9.087 cr** contained **undeclared** information of the **mode of contribution** and formed **0.14%** of the total donations declared by the parties.
- Rs 1106.475 cr** comprising of **5883 donations** declared as received by the National Parties through **Bank Transfer** for FY 2024-25.




**IV. Donors from Corporates/business sectors Vs. Individual donors**

- a) **Corporates/business sectors have been segregated from individual donations by ADR** as this segregation is not a part of the form submitted by the political parties to the ECI.
- b) **3244 donations from corporate/business sectors** amounting to **Rs 6128.787 cr** were made to the National parties while **7900 individual donors** donated **Rs 505.66 cr** to the parties during FY 2024-25.
- c) With the maximum number of donations during FY 2024-25, **BJP** has declared **2794** donations from **corporate/business sectors** amounting to **Rs 5717.167 cr** while **2627** individual donors donated **Rs 345.94 cr** to the party.
- d) Donations from corporates formed **94.13%** of total donations declared by **BJP**.
- e) **112** donations from **corporate/business sectors** amounting to **Rs 383.8605 cr** were made to **INC** while **2357** individual donors donated **Rs 132.3885 cr** to the party.
- f) Donations from corporates formed **74.19%** of total donations declared by **INC**.


**V. State-wise donations to National Parties, FY 2024-25**

- Segregation of donations according to state was made by ADR based on the address provided by the parties in their donations report to the ECI.
- Donations declared by the National parties contained details of **donations received from 33 States/Union Territories/ common capitals**. Please refer to **Annexure-2** for more details.
- A total of **Rs 2639.481 cr** was donated to the National parties from **Delhi**, followed by **Rs 2438.86 cr** from **Maharashtra** and **Rs 309.177 cr** from **Gujarat**.
- A total of **Rs 7.684 cr**, (0.115% of total donations received by the National parties, FY 2024-25), could not be attributed to any State/ Union Territory due to **Undeclared address** provided by the parties.

- e) Of the donations from **corporate houses**, Rs 5.816 cr could **not be segregated** into donations from various states.
- f) **Corporate/ Business houses** from **Delhi** donated Rs 2598.462 cr while those from **Maharashtra** gave Rs 2299.93 cr.

**Top 5 states which contributed to National Parties, FY 2024-25 (in Rs Cr)**





**VI. Incomplete disclosure of information in the donations report**

- a) Of the 6 National parties, 4 parties namely BJP, CPI(M), INC, NPEP and had **not declared PAN** details of **205 donations** through which the parties collected a total of **Rs 3.468 cr**.

- b) **BJP** collected **Rs 2.625 cr** from **174 donations** but failed to provide PAN details of donors. **CPI(M)** collected **Rs 46.90 lakhs cr** from **22 donations**, **INC** collected **Rs 32.40 lakhs** from **4 donations** and **NPEP** collected **Rs 5 lakhs** from **5 donations** without PAN.
- c) 3 National parties (INC, BJP and CPI(M)) have declared **33 donations** of **Rs 38.80 lakhs** having **missing/incorrect PAN** details for FY 2024-25.
- d) **CPI(M)** declared **Rs 23.90 lakhs** from **20** donations with missing/incorrect PAN details of donors. **BJP** collected **Rs 8.40 lakhs** from **9** donations without complete PAN and **4 donations** of **INC (Rs 6.50 lakh)** do not have complete PAN details.


**VIII. Month-wise donations received by National Political Parties**

- Only **Communist Party of India (Marxist)** shows consistent month-wise reporting, revealing relatively small and stable donations across the year.
- CPI(M)** collected maximum donations in **April 2025**, a total of **Rs 1.174 cr** from 34 donations and party has declared **Rs 26.24 lakhs** from 21 donations in **July 2024**. In addition, CPI(M) has also not declared the payment dates for **507 donations amounting to Rs 14.398 cr**.
- BJP, INC, AAP and NPEP have not declared the dates of payment for all donations. BJP has not declared the payment dates for **5,522 donations amounting to Rs 6,074.015 cr**, INC for **2,501 donations amounting to Rs 517.394 cr**, AAP for **2,554 donations amounting to Rs 38.106 cr**, and NPEP for **25 donations amounting to Rs 2.091 cr**.

**IX. Range of Contributions received by National Parties**

- a) National political parties received a total of **11,343 donations** worth **Rs 6648.563 cr**. ADR has segregated these donations into different ranges by amount.
- b) Parties received **11 contributions exceeding Rs 100 crore** and forming a share of **37.387 %**.
- c) National Political Parties received **12 contributions** from **Rs 50,00,00,001 to 100 cr** amounting to **Rs 1041.349 cr** and formed 15.663% of the total share of contributions received.
- d) The National parties received the largest contribution of Rs 4024.4347 cr from the four Electoral Trusts (Prudent, Progressive, Ab General and New Democratic), which makes up 60.53% of the total donations.
- e) Maximum number of contributions (**3987**) received by National Parties were between Rs 20,000 to **Rs 1 lakh**, and amounted to **Rs 22.075 cr** with a total share of **0.332%**.
