Summary and Highlights

Association for Democratic Reforms (ADR) and **Maharashtra Election Watch** have analysed the self-sworn affidavits of **37** candidates belonging to 5 major parties, who are contesting in the **Municipal Corporation Bye Elections** scheduled to be held in **Thane, Aurangabad, Nashik, Parbhani, Amravati and Dhule districts, on 28th August, 2016.**

Shiv Sena candidate **Smt. Dahake Praveena Digambar** contesting on **Ward no 32 B (Navathe Plot)** seat for **Amravati** district, shall by default be elected **unopposed** in the upcoming election. Due to unavailability of candidates' affidavits from **Latur** district, ADR could not analyse same.

Bye Elections are being held for only 10 wards spread in above 7 districts, details of which are as follows –

Criminal Background

- **Candidates with Criminal Cases:** 4 (11%) candidates have declared criminal cases against themselves. **Out of these 4 candidates, 2 are from major parties and 2 are independents.**

- **Candidates with Serious Criminal Cases:** 2 (5%) candidates have declared serious criminal cases against themselves like **criminal intimidation, theft in dwelling house, cheating, etc.**

- **Party wise Candidates with declared Criminal Cases:**

1 (13%) out of **8** candidates analysed from **Shiv Sena** viz. **Smt. Sangeeta Chandragupta Ghagh**, contesting from ward no 32 A (Thane district) and **1 (20%)** out of **5** candidates analysed from **INC** viz. **Mr. Unahvane Shashikant Sukhdev** from ward no 36 B (Nashik district) have declared **criminal cases** against themselves in their affidavits.

- **Party wise Candidates with declared Serious Criminal Cases:** **1 (20%)** out of **5** candidates analysed from **INC**, as mentioned above, has declared **serious criminal cases** against himself in his affidavit.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Financial Background

- **Crorepati Candidates:** Out of the 37 candidates analyzed, 7 (**19%**) are crorepatis, of which 4 belongs to major parties and 3 are independents.
- **Party-wise Crorepati Candidates:** 3 (**38%**) out of 8 candidates analysed from **Shiv Sena** and 1 (**20%**) out of 5 candidates analysed from **INC** are crorepatis.

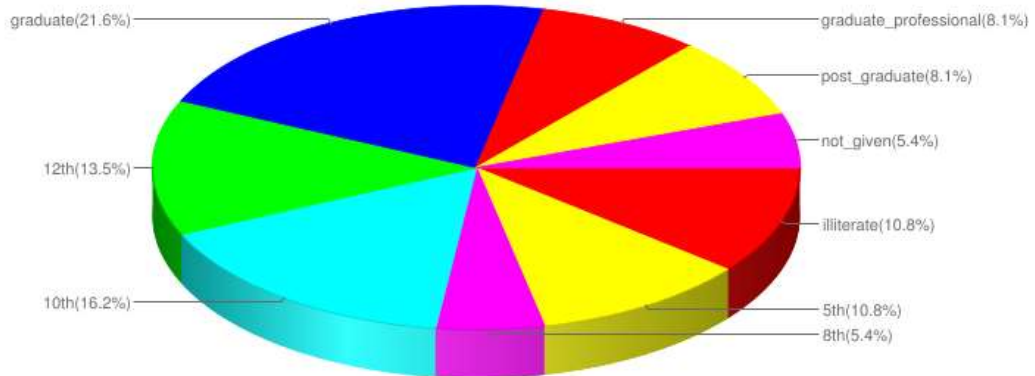
