- There are **2(17%)** candidates who have declared criminal cases against themselves.
- **6(50%)** candidates are crorepatis.
- The average assets per candidate contesting in the Andaman and Nicobar Islands for Lok Sabha Elections 2024 is **Rs. 3.06 crores**.
- There are **9** candidates who have declared liabilities.
- **2** female candidates are contesting in the Andaman and Nicobar Islands for Lok Sabha election 2024.

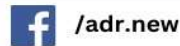
