Lok Sabha 2019 Assam (Phase- II)

Criminal Background, Financial, Education, Gender and other details of Candidates

The Assam Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **49 out of 50** candidates.

One candidate has not been analysed due to the unavailability of his complete affidavit on the ECI website. The details of candidate are given below:

- There are 4 (8%) candidates who have declared criminal cases against themselves. Out of these, 3 have declared serious criminal cases against themselves.
- 11(22%) candidates are crorepati.
- The average asset per candidate contesting in the lok Sabha Phase II from Assam is Rs. 1.26 crores.
- There are candidates 18 candidates who have declared liabilities.
- There are only 2 women candidates contesting in Lok Sabha phase II from Assam.
