Jammu & Kashmir Lok Sabha Elections, 2024

Jammu & Kashmir Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of all 20 candidates, who are contesting in the Anantnag-Rajouri constituency in Jammu & Kashmir Phase-III Lok Sabha elections 2024.

<u>Criminal Background, Financial, Education, Gender and other details of Candidates</u>

- There are **3(15%)** candidates who have declared criminal cases against themselves. Out of these, **2(10%)** have declared serious criminal cases against themselves.
- 5(25%) candidates are crorepati.
- There are 6 candidates who have declared liabilities.
- Out of 20 candidates, 2(10%) female candidates are contesting.


