Jammu & Kashmir Lok Sabha Elections, 2024

Jammu & Kashmir Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of all **24** candidates, who are contesting in the Srinagar constituency in Jammu & Kashmir Phase-IV Lok Sabha elections 2024.

Criminal Background, Financial, Education, Gender and other details of Candidates

- There are **4(17%)** candidates who have declared criminal cases against themselves. Out of these, **2(8%)** have declared serious criminal cases against themselves.
- **8(33%)** candidates are crorepatis.
- There are **10** candidates who have declared liabilities.
- Out of **24** candidates, **2(8%)** female candidates are contesting.
