### Criminal Background, Financial, Education, Gender and other details of Candidates

- None of the candidates have declared criminal cases against themselves.
- **2(67%)** candidates are crorepatis.
- The average assets per candidate contesting in the Ladakh for Lok Sabha 2024 is **Rs. 1.93 crores**.
- There is no woman candidate contesting.
