## Summary and Highlights

The Goa Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **all 12** candidates, who are contesting in the **North Goa and South Goa constituency in the Goa Elections**.

### Criminal Background

- **Candidates with Criminal Cases:** Out of **12** candidates analyzed, **3** candidates have declared criminal cases against himself. Among these 3 candidates, 2 candidates have declared serious criminal cases against themselves. The details of these 3 candidates are given below :

2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Party Wise Crorepati Candidates**: Among the major parties, 2(100%) candidates from BJP, 2 (100%) candidates from INC, 1 (50%) candidate out of 2 candidates from AAP, and 1(25%) out of 4 independent candidates are crorepatis.
