राजनीतिक दल लगातार ऐसे सासंद / विधायकों को टिकट दे रहे हैं जिन्होंने अपने विरुद्ध धार्मिक समूहों की भावनाओं को भड़काने और उनके बीच शत्रुता को बढावा देने जैसे मामले घोषित किये हैं।

ऐसे उम्मीदवारों को टिकट दिया गया है जिन्होंने अपने विरूद्ध धार्मिक भावनओं और उनके बीच शत्रुता की भावनाओं का भड़काने का कृत्य घोषित किया है। राजनीतिक दलों ने ऐसी परिस्थितियों को बढ़ावा दिया है जिसके कारण विभिन्न समूहों के बीच इस तरह के सांप्रदायकि दंगे और हिंसा का बढ़ावा मिला है।

ऐसोसिएशन फॉर डेमोक्रेटिक रिफार्म्स (एडीआर) और नेशनल इलेक्शन वॉच (एनईडब्लयू) ने 2008 से सभी लोकसभा और विधानसभा चुनावों में लड़ने वाले उम्मीदवारों के शपथपत्रों का विश्लेषण किया है। हमारे विश्लेषण के इस भाग को भारतीय दंड सहिता के निम्न वर्गों में देखा जा सकता है—

- 153 क (धर्म, मूलवंश, भाषा, जन्मस्थान, निवास स्थान, इत्यादि के आधारों पर विभिन्न समूहों के बीच शत्रुता का संप्रवर्तन और सौहार्द्र बने रहने पर प्रतिकूल पभाव डालने वाले कार्य करना)
- 295 (किसी वर्ग के धर्म का अपमान करने के आश्य से उपासना के स्थान को क्षिति करना या अपवित्र करना)
- 295 क (विमर्शित और विद्वेषपूर्ण कार्य जो किसी वर्ग के धर्म या धार्मिक विश्वासों का अपमान करके उसकी धार्मिक भावनओं को आहत करने के आश्य से किए गए हों)

अस्वीकृतिः

- यह संकलन उम्मीदवारों द्वारा चुनाव के समय भारतीय चुनाव आयोग को दिये गये उनके शपथपत्रों पर आधारित है।
- एडीआर और एनईडब्लयू उम्मीदवारों की वर्तमान आपराधिक गतिविधि से परिचित नही है। हम नया संकलन इन उम्मीदवारों के दोबारा चुनाव लड़ने और इनके द्वारा दिये गये नये शपथ पत्रों के आधार पर प्रस्तुत करेंगें।

- वर्तमान सांसद, आईपीसी 153 'क' के तहत मामलेः 11 सासंदो ने आईपीसी 153 'क' के तहत अपने विरूद्ध आपराधिक मामले घोषित किये हैं। 11 में से 9 लोकसभा और 2 राज्यसभा के सांसद है।
- वर्तमान विधायक, आईपीसी 153 'क' के तहत मामलेः 26 विधायकों ने आईपीसी 153 'क' के तहत अपने विरूद्ध आपराधिक मामले घोषित किये हैं।





- वर्तमान सांसद, आईपीसी 295 'क' के तहत मामलें: 3 सासंदों ने आईपीसी 295 'क' के तहत अपने विरुद्ध आपराधिक मामलें घोषित किये हैं। (सांसदों और विधायकों के बीच आईपीसी। की धारा 295 क, 295 और 153 क के तहत ओवरलेप हो सकता है। वे परस्पर अनन्य नहीं है।)
- वर्तमान विधायक, आईपीसी 295 'क' के तहत मामलें: 9 विधायकों ने आईपीसी 295 'क' के तहत अपने विरुद्ध आपराधिक मामलें घोषित किये हैं। (सांसदो और विधायकों के बीच आईपीसी। की धारा 295 क, 295 और 153 क के तहत ओवरलेप हो सकता है। वे परस्पर अनन्य नहीं है।)
- वर्तमान सांसद, आईपीसी 295 के तहत मामले: 3 सासंदों ने आईपीसी 295 के तहत अपने विरुद्ध आपराधिक मामले घोषित किये हैं। (सांसदों और विधायकों के बीच आईपीसी की धारा 295 क, 295 और 153 क के तहत ओवरलेप हो सकता है। वे परस्पर अनन्य नहीं है।)
- वर्तमान विधायक, आईपीसी 295 के तहत मामले: 5 विधायकों ने आईपीसी 295 के तहत अपने विरुद्ध आपराधिक मामले घोषित किये हैं। (सांसदो और विधायकों के बीच आईपीसी की धारा 295 क, 295 और 153 क के तहत ओवरलेप हो सकता है। वे परस्पर अनन्य नहीं है।)
- दलवार वर्तमान सांसद, आईपीसी 153 'क' के तहत मामलें: सभी प्रमुख्य दलों में भाजपा के 14 सांसद / विधायक (7 सासंद, 7 विधायक), एआईएमआईएम के 5 सांसद / विधायक (1 सासंद / 4 विधायक), सपा के 4 सांसद / विधायक (1 सांसद / 3 विधायक), टीआरएस के 4 विधायकों नें, जेडीयू के 2 सांसदों ने और कांग्रेस, डीएमके, आरजेडी, पीएमके के 1 सांसद ने आईपीसी की धारा 153 'क' के तहत आपराधिक मामलें घोषित किये हैं।
- राज्यवार —वर्तमान विधायक, आईपीसी 153 'क' के तहत मामलेः सभी राज्यों से उत्तरप्रदेश के 12 सांसद / विधायक (4 लोकसभा सासंद, 1 राज्यसभा सांसद और 7 विधायक), आन्ध्र प्रदेश के 10 सांसद / विधायक (1 लोकसभा सासंद, 1 राज्यसभा सांसद और 8 विधायक), बिहार के 4 विधायकों ने, कर्नाटक के 4 सांसद / विधायक (2 सासंद और 2 विधायक), तिमलनाड् के 3 सांसद / विधायक (1 सासंद और 2 विधायक) ने आईपीसी की धारा 153 'क' के तहत आपराधिक मामले घोषित किये हैं।
- दलवार वर्तमान सांसद, आईपीसी 295 'क' के तहत मामलें: सभी प्रमुख्य दलों में भाजपा के 5 सांसद / विधायक (1 सासंद, 4 विधायक) और एआईएमआईएम के 5 सांसद / विधायक (1 सासंद / 4 विधायक) ने आईपीसी की धारा 153 'क' के तहत आपराधिक मामले घोषित किये हैं। (सांसदों और विधायकों के बीच आईपीसी की धारा 295 क, 295 और 153 क के तहत ओवरलेप हो सकता है। वे परस्पर अनन्य नहीं है।)

आईपीसी 153 'क', 295 और 295 'क' जैसे मामले घोषित करने वाले उम्मीदवार और राजनीतिक दलों द्वारा उन्हे दिये गये टिकट

- आईपीसी 153 'क' के तहत आपराधिक मामले घोषित करने वाले उम्मीदवार : 2008 से लोकसभा और विधानसभा चुनाव लड़ने वाले 80 उम्मीदवारों ने अपने विरूद्ध आईपीसी 153 'क' के तहत मामले घोषित किये, लेकिन वे चूनाव में पराजित हुए।
- दलवार आईपीसी 153 'क' के तहत आपराधिक मामले घोषित करने वाले उम्मीदवार : प्रमुख दलों से लोकसभा और विधानसभा में चुनाव लड़ने वाले 80 उम्मीदवार है जो पराजित रहे वह है: भाजपा के 13, सपा के 7, कांग्रेस के 6, बसपा के 6, शिवसेना के 2 और एमएनएस के 2 थे।





- राज्य वार आईपीसी 153 'क' के तहत आपराधिक मामले घोषित करने वाले उम्मीदवार : सभी राज्यों से लोकसभा और विधानसभा में चुनाव लड़ने वाले 80 उम्मीदवार है जो पराजित रह वह है: उत्तरप्रदेश के 25, तमिलनाडू के 8, कर्नाटक के 7, महाराष्ट्र के 6, मध्यप्रदेश के 4, उडीसा और पंजाब के 3–3 और वेस्ट बंगाल के 2 थे।
- <u>आईपीसी 295 'क' के तहत आपराधिक मामले घोषित करने वाले उम्मीदवार</u> : 2008 से लोकसभा और विधानसभा चुनाव लड़ने वाले 20 उम्मीदवारों ने अपने विरूद्ध आईपीसी 153 'क' के तहत मामले घोषित किये, लेकिन वे चुनाव में पराजित हुए।
- दलवार आईपीसी 153 'क' के तहत आपराधिक मामले घोषित करने वाले उम्मीदवार : प्रमुख दलों से लोकसभा और विधानसभा में चुनाव लड़ने वाले 20 उम्मीदवार है जो पराजित रहे वह है: बसपा के 6, भाजपा के 3, और सीपीआईएमएल के 2 थे।
- <u>आईपीसी 295 के तहत आपराधिक मामले</u> घोषित करने वाले उम्मीदवार : 2008 से लोकसभा और विधानसभा चुनाव लड़ने वाले 31 उम्मीदवारों ने अपने विरूद्ध आईपीसी 295 के तहत मामले घोषित किये, लेकिन वे चुनाव में पराजित हुए।
- एडीआर और एनईडब्लयू दृढ़ता से सिफारिश करता है कि राजनीतिक दलों को ऐसे उम्मीदवारों को टिकट नही देना चाहिए जिनके विरूद्ध आपराधिक मामले दर्ज हों। आपराधिक पृष्ठभूमि वाले उम्मीदवारों को चुनाव लड़ने से वंचित किया जाना चाहिए और राजनीतिक दलों को उम्मीदवारों को टिकट दिये जाने के मापदंड का खुलासा करने के लिए मजबूर किया जाना चाहिए। सांसदो और विधायकों के विरूद्ध आपराधिक मामलों के लिए फास्ट ट्रेक कोर्ट का प्रबन्ध किया जाना चाहिए।
