Subject: Upward revision of sale prices of Customs
Confiscated Non-prohibited bore weapons
allotted to the Members of Parliament/Other
VIPs-Regarding

Madam,

The question of pricing of the non-prohibited bore weapons (firearms) allotted to the Members of Parliament/other VIPs by Customs has been reviewed. In supersession of instructions in this Ministry's letter of even number (Part) dated 25.6.93 (copy enclosed) on the above subject, I am directed to say that it has been decided to revise the pricing of non-prohibited bore weapons with immediate effect, with the approval of the Finance Minister. Instead of following the earlier pricing system, the future sale of the weapons by Customs be made on the prices fixed/determined on the basis of the prevailing likely CIF prices of the weapons for import into India plus the Customs duty leviable i.e. @ 150% Ad-valorem plus 10% of the CIF-cum-duty prices, as illustrated below. [Sales Tax as applicable will be chargeable on this price in addition].

Illustration: Suppose the C.I.F. price of a particular model of a NPB weapon is Rs. 8000/-.
The Sale price of the said weapon shall be fixed/determined as under:-

a)	C.I.F. price	-	Rs. 8000/-
b)	Customs duty @150% Ad-valorem	-	Rs.12000/-
c)	C.I.F. cum duty price (a)+(b)	-	Rs.20000/-
d)	10% of C.I.F. cum duty price (c)	-	Rs. 2000/-
e)	Sale Price (c)+(d)	-	Rs.22000/-
	(Sales Tax extra as applicable)		

2. Though normally no regular imports of weapons are permitted, but as ascertained, occasional release of the weapons to returning Indian diplomats etc. on transfer of residence is permitted and the prices for duty purposes being determined. These prices could be made use of for

determining the likely CIF prices of identical/similar models of weapons of same manufacturer.

3. Wherever prices of particular models of weapons for sale by the Department to MPs/VIPs are not easily forthcoming, the latest available price lists, as available on INTERNET could be taken into account. As these prices in the country of sale are generally inclusive of all taxes & incidentals etc., it has also been decided that an average deduction of 33% could be given over these prices for notionally arriving at the CIF prices for the particular models (or somewhat nearest comparable/ similar models) for import into India.

4. A copy of the illustrative list of prices of various models of weapons available on INTERNET and forwarded by Addl. Commissioner(Gen.), New Custom House, Mumbai, is enclosed for ready reference.

5. The prices of various brands of weapons (non-prohibited bore) available with you for disposal, may accordingly be fixed on immediate basis, latest within a week's time, and the Ministry be also kept informed of the erstwhile and revised prices in respect of different brands/ types of weapons available with you, which are ripe for disposal.

SUBJECT: Policy of disposal of confiscated
fire-arms.

F/K

With effect from October, 1987 and with the approval of the then Finance Minister, the following policy is being followed with regard to the disposal of fire-arms confiscated by the Customs Department under the provisions of the Customs Act, 1962:-

- "(i) The prohibited bore weapons will be confiscated and appropriated only for the Departmental use;
- (ii) Confiscated non-prohibited bore weapons would be given to the departmental officers on lease terms on a selective basis subject to the condition that on retirement/superannuation, these weapons would be returned to the Department.
- (iii) If after meeting these two requirements, non-prohibited bore confiscated weapons were available, those can be sold to Members of Parliament at a price to be fixed by the Pricing Committee which should be only 5% less than the prevailing market price for that type of weapon. The Members of Parliament will be sold available weapons on first-come-first serve basis. Finance Minister's order has to be taken in each specific case."

2. With effect from March, 1990, however, it was decided to sell the NP bore weapons to the Members of Parliament at the c.i.f. value plus 250% customs duty instead at the price as fixed in (iii) above.

3. The number of non-prohibited bore weapons now available for disposal is about 100 and some of these will be required for the Department's own use.

4. However, NP bore weapons found surplus to requirement of the Department can be sold to Members Parliament and other VIPs such as Members of the Planning Commission, Members of the Minorities Commission, etc. who hold ranks higher than that of the Members of Parliament on a first-come-first-serve basis with the approval of Finance Minister in each specific case. Resale of the weapons would ordinarily not be permitted. If in exceptional circumstances, such permission is granted, resale would have to be at a price lower than the one at which the weapon was purchased and that too only to persons, i.e., MPs, etc.
