Summary and Highlights

The Jharkhand Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **41 out of 42** candidates, who are contesting in the following constituencies in the Jharkhand, Lok Sabha Phase 7 Elections.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Affidavit of **Bajrangi Mahtha** of **Bahujan Mukti Party** from **Godda** constituency has not been analysed due to the unavailability of his properly scanned and complete affidavit on the ECI website, at the time of making this report.
