Jharkhand Assembly Elections 2009

Jharkhand Assembly elections 2009 were held in five phases from November 16, 2009 to December 13, 2009. This report includes the analysis of voting trends, criminalization, money power, gender etc in these elections. Information provided by ECI and details from the affidavits filed by contesting candidates have been used for above analysis.

Executive summary for candidates and MLAs

Summary for candidates

- Affidavits of 1018 candidates out of 1060 candidates were analyzed by Jharkhand Election Watch (JEW) for Jharkhand assembly elections 2009.
- Out of these 1018 candidates, 329 candidates or 32% declared pending criminal cases against them. A total of 50 candidates out of 78 of JMM (64%) had pending criminal cases, JVM (P) had 14 out of 24 (58%) and INC had 30 out of 60 (50%) candidates with pending criminal cases. More than 40% of candidates of BJP, RJD and AJSU had pending criminal cases against them.
- Out of these 329 candidates with pending criminal cases, 158 had pending serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc. JMM had 23, AJSU- 14, RJD- 13, JVM(P)-10 and INC -12 candidates with pending serious criminal cases.
- There were 313 candidates of five main parties (INC, BJP, AJSU, RJD & JMM) and out of these 313 candidates 157 (47.72%) had pending criminal cases against them. Comparing this to Assembly 2005 elections, there were 113 candidates of five major parties-INC, BJP, AJSU, RJD & JMM. Out of these 113 candidates of five major political parties 46 (40.70%) had pending criminal cases against them.
- There were 409 IPC charges of heinous nature on the candidates which included murder, attempt to murder, kidnapping, extortion, etc.
- There were total 59 Red Alert constituencies where 3 or more contesting candidates had pending criminal cases. Dhanbad constituency had 11 candidates with pending criminal cases followed by Biashrampur constituency which had 10 candidates with pending criminal cases.
- A total of 73 candidates out of 1018 i.e. 7.17% were crorepatis.
- A total of 4 candidates declared zero assets.
- A total of 131 candidates declared liabilities above Rs. 5 lakhs.
- Among major parties, the average asset per candidate for INC was Rs. 1.68 crore, for JVM (P) was Rs 90.69 lacs, for JMM was Rs 56.58 Lacs, for BJP was Rs 46.36 lacs, for RJD was Rs 40.68 lacs and for AJSU was Rs 29.31 lacs.
- 59.62% of candidates (607 of 1018) had not furnished PAN card details.
- More than 38% candidates (387 of 1018) were graduates & above.

Summary for MLAs

- Of the 20 candidates with the most serious criminal cases against them, only 3 won and the remaining 17 were rejected by the voters.
- Out of 81 MLAs, 59 (72.84%) have pending criminal cases against them. Comparing this to Assembly Election 2005, affidavits were available for 72 MLAs out of which 31 (43.06%) had pending criminal cases against them.
- Out of these 59 MLAs with pending criminal cases, there are pending serious criminal cases against 26 MLAs (32.10%).
- Out of these 59 MLAs with pending criminal cases, 17 are of JMM, 11 are of INC, 8 each of BJP and JVM (P) and 4 each of RJD and AJSU. Contrasting this with 2005 Assembly Election, 18 MLAs (25 %) had serious pending criminal cases.
- As the number of MLAs with pending criminal cases has increased from 31 in Assembly Election 2005 to 59 in Assembly Election 2009, so has the number of total criminal cases pending against MLAs from 93 in Assembly election 2005 to 156 in Assembly Election 2009. Similarly the number of total serious IPC sections against MLAs has increased from 43 in 2005 to 52 in 2009.
- The number of crorepati MLAs has increased from 2 in Assembly Election 2005 to 21 in Assembly Election 2009.
- Among major parties, the average asset per winner for INC Rs 1.90 crore, JVM(P) 1.13 crore, JMM Rs 86.70 lacs, BJP Rs 35.94 lacs, AJSU 44.98 lacs, and for RJD 72.03 lacs.
- Average asset for a MLA from Jharkhand Assembly was 91 lacs.
- Out of 81 MLAs, 17 had not declared their PAN details.

Party wise break up of candidates and MLAs

Jharkhand has 81 assembly constituencies. BJP and JMM had maximum number of MLAs (18) each followed by INC having 14 MLAs out of 60 candidates. AJSU and RJD each had 5 winning candidates. The breakups of winners as compared to total candidates from the party are-

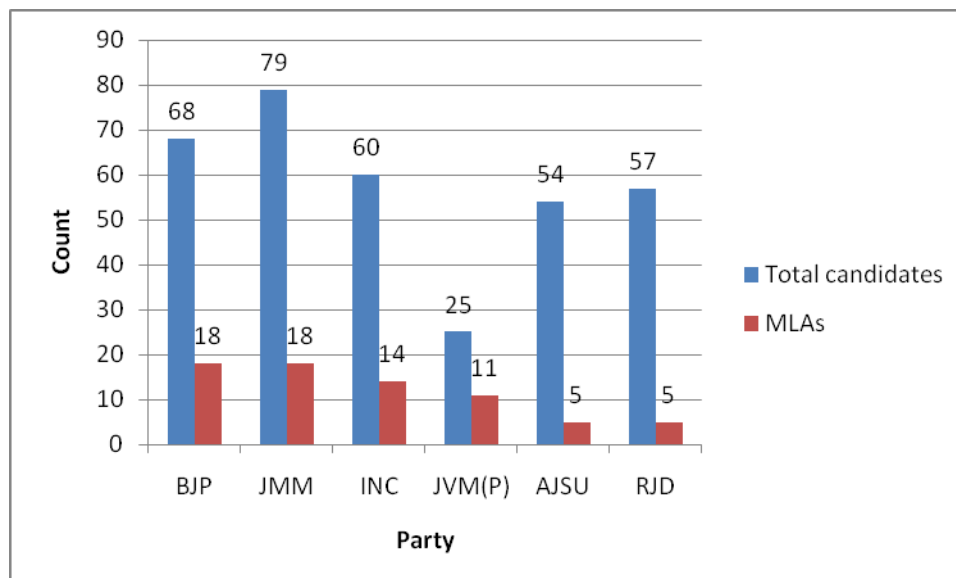


Figure: Candidates & MLAs – party wise break up

Analysis based on pending criminal cases

Analysis based on pending criminal cases- for candidates

A total of 1018 affidavits were analyzed by Jharkhand Election Watch for 2009 Jharkhand assembly elections. Out of these 1018 candidates, 329 candidates or 32.32% declared pending criminal cases against them. Out of these 329 candidates with pending criminal cases, 158 had pending serious criminal cases like murder, attempt to murder, kidnapping, robbery, extortion etc.

Party wise break up for candidates with pending criminal cases

A total of 329 candidates in Jharkhand Assembly 2009 elections had pending criminal cases against them. A total 50 candidates out of 78 candidates of JMM (64%) had pending criminal cases, JVM (P) had 14 out of 24 (58%), INC had 30 out of 60 (50%) candidates with pending criminal cases. More than 40% of candidates of BJP, RJD and AJSU had pending criminal cases against them.

Out of these 329 candidates with pending criminal cases, 158 had pending serious criminal cases against them. These serious cases include murder and related charges, kidnapping, extortion, dacoity, theft, robbery etc. JMM had 23, AJSU had 14, RJD had 13, JVM (P) had 10 and INC had 12 candidates with pending serious criminal cases. 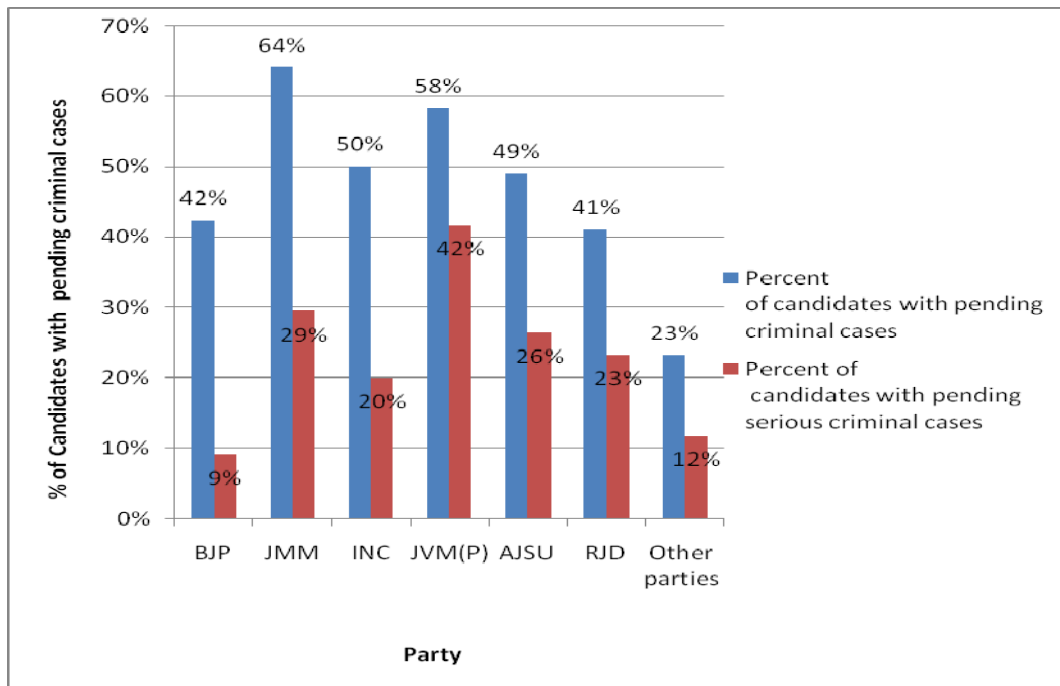


Figure: Comparison of pending criminal cases and serious pending criminal cases for candidates of main parties

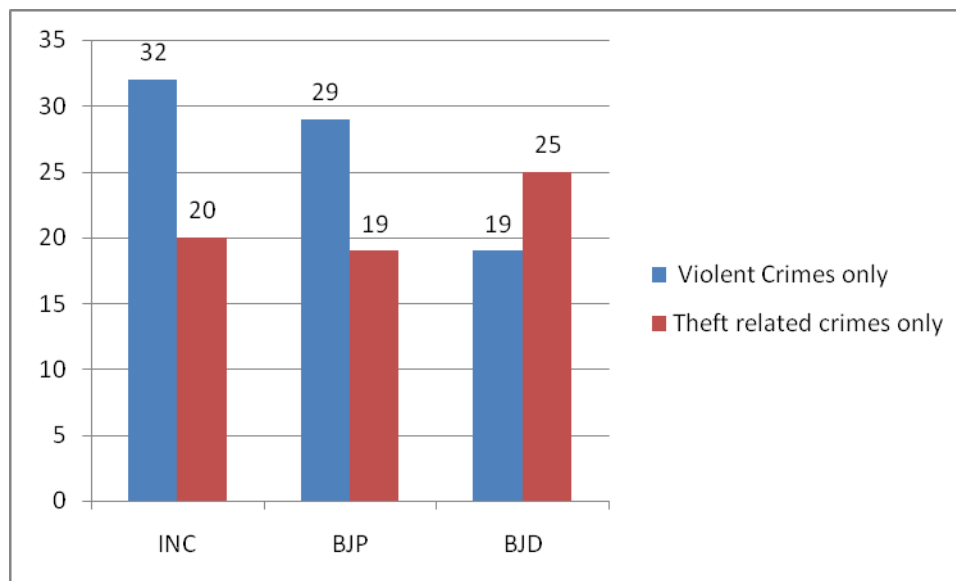


Figure: Serious IPC section break up for candidates of major parties

Party wise comparison of pending criminal cases of candidates in Jharkhand Assembly 2009 & 2005

A comparison between candidates with pending criminal cases in Assembly 2005 & Assembly elections 2009 of five major parties shows that for four major parties- BJP, JMM, INC & RJD the number of Analysis of the candidates & MLAs of Jharkhand (based on 2009 assembly elections)

candidates with pending criminal cases has increased in 2009 elections as compared to 2005 elections. On the other hand, the number of candidates of AJSU with pending criminal cases has decreased in 2009 elections as compared to 2005 elections. This can be seen from table below.

Top 20 candidates with pending criminal cases

The table below lists top 20 candidates with serious pending criminal cases against them. Almost all of them had pending criminal cases of murder, attempt to murder, kidnapping, dacoity etc. Yugal Pal from Bishrampur had 21 charges of murder and attempt to murder etc pending against him. Keshav Yadav had 16 charges of murder, attempt to murder & kidnapping etc pending against him. Out of these 20 candidates with most serious pending criminal cases, only 3 won and rest 17 were rejected by the voters. The detailed list is given below.

Analysis based on pending criminal cases – for MLAs

Out of 81 MLAs in Jharkhand assembly 2009, 59 MLAs have pending criminal cases against them. Out of these 59 MLAs, there are pending serious criminal cases against 26 MLAs (32.1% of total MLAs). Contrasting this with 2005 Jharkhand Assembly election, only 18 MLAs (22.22%) had serious pending criminal cases. There is 44% increase in MLAs with pending serious criminal cases from assembly 2005 to assembly 2009 election.

Given below is a comparative analysis for MLAs with pending criminal cases elected in Jharkhand assembly election. The presence of MLAs with pending criminal cases in Jharkhand assembly election has increased by 90%.

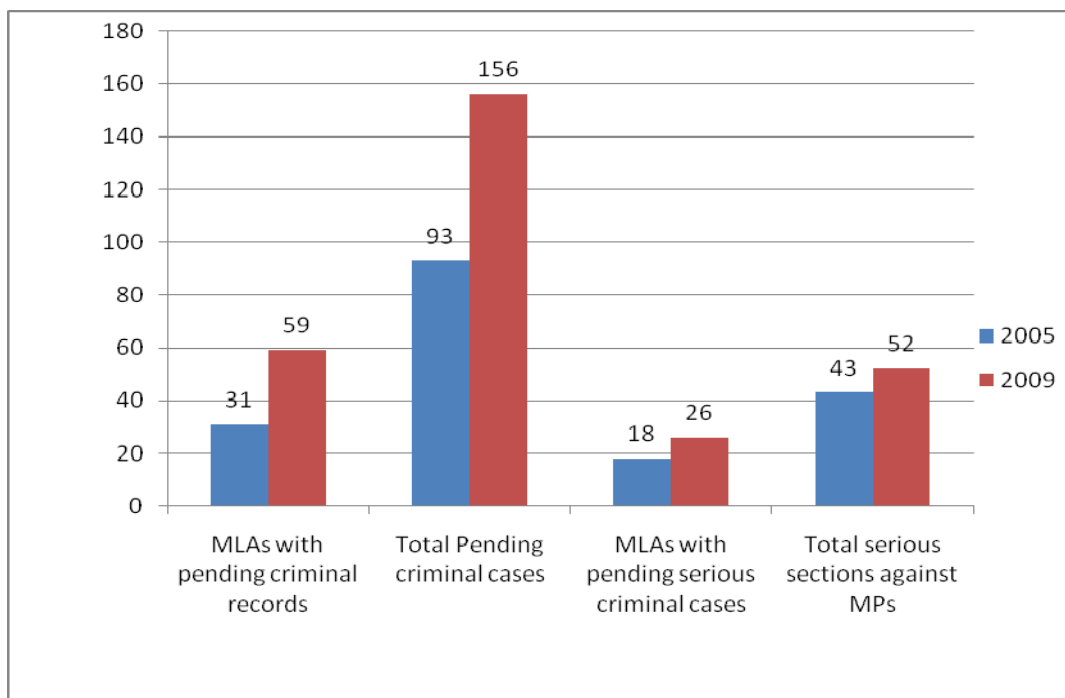


Figure: Comparison Jharkhand Assembly 2005 & 2009- MLAs with pending criminal cases

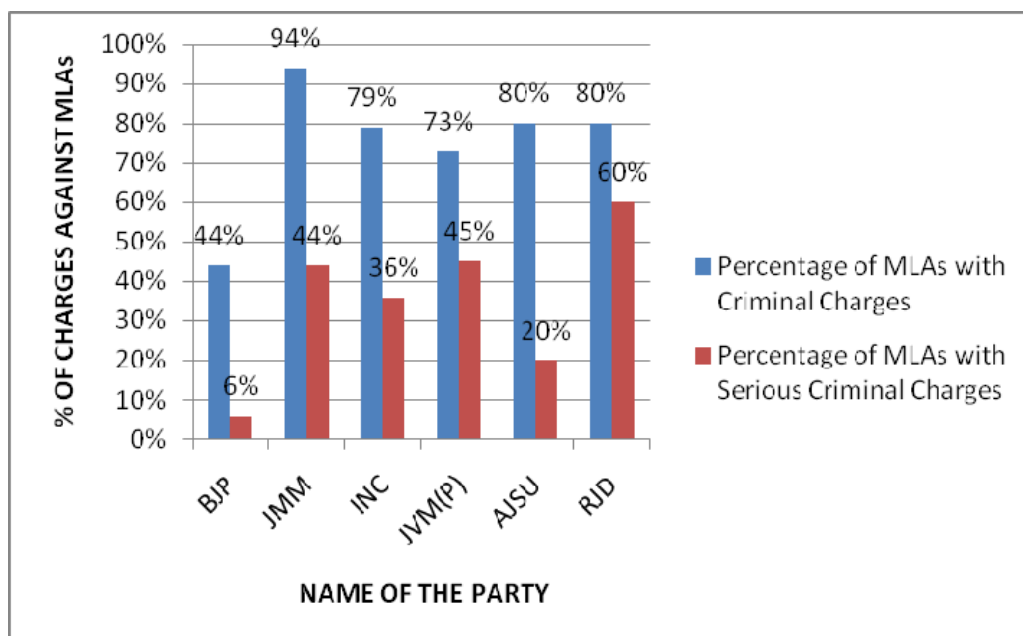


Figure: % MLAs with pending criminal cases

Analysis based on assets – for candidates

Out of 1018 candidates contesting Jharkhand assembly 2009 Elections, 73 were crorepatis. INC had 25% crorepati candidates, JVM (P) had 21%, JMM had 18% while BJP had 14% of its candidates as crorepatis.

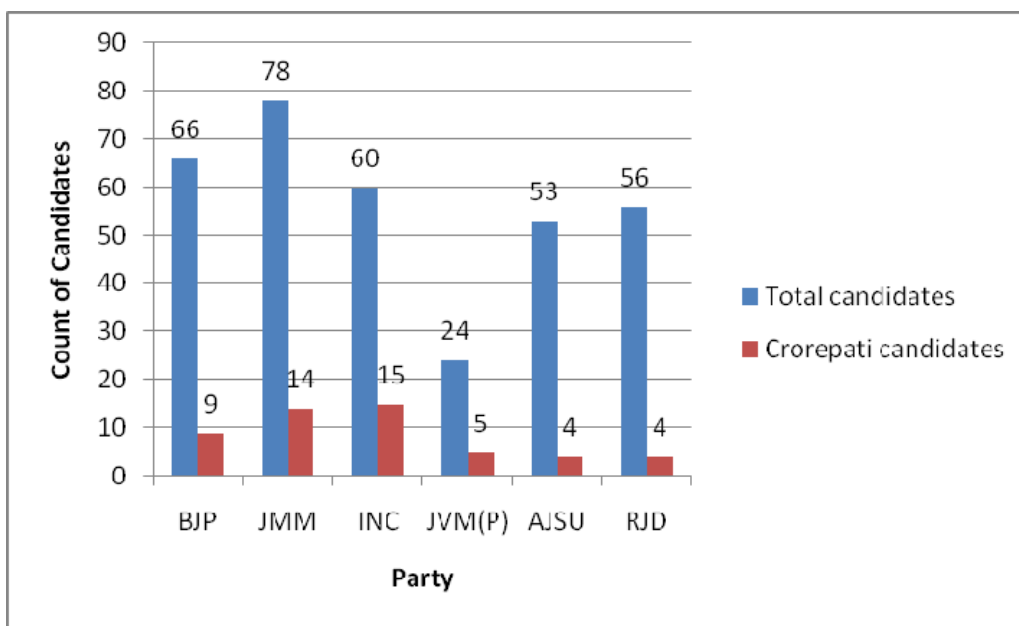


Figure: Crorepati candidates from major parties

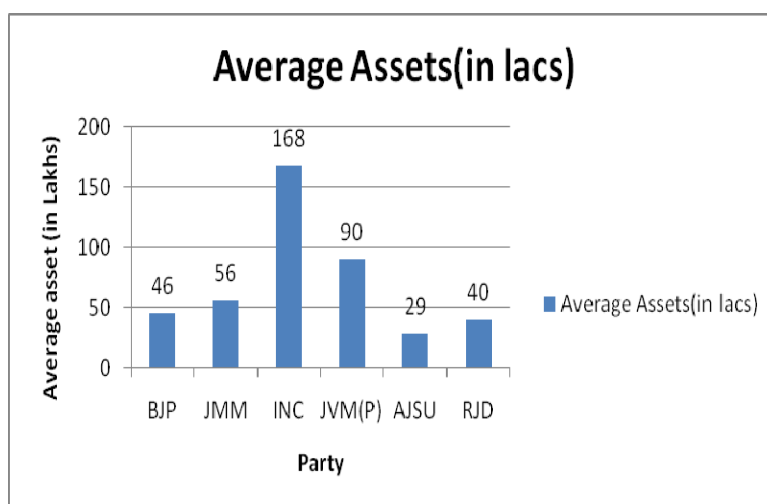


Figure: Average assets for candidates- party wise

Analysis based on assets- for MLAs

Out of 81 MLAs in Jharkhand assembly 2009, 21 MLAs are crorepatis. Comparing it to Jharkhand assembly 2005, only 2 MLAs were crorepatis in the last assembly. The average asset of an MLA in 2005 Jharkhand assembly was Rs 2.5 cr which rose to Rs 9.1 cr in 2009. Between 2005 & 2009 there has been an average asset increase of 72% for MLAs.

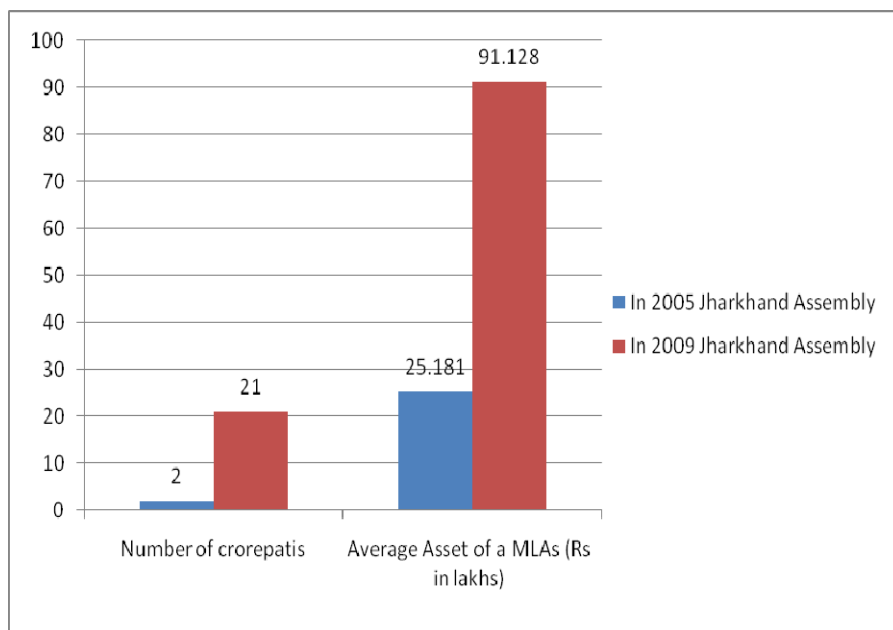


Figure: Comparison Assembly 2005 and 2009 based on assets

Chances of winning based on assets

As can be seen from the table, the higher the assets the more are the chances of winning of a candidate. A total of 29% of the candidates who had declared assets of Rs 5 crore and above won the elections. On the other hand less than 2% of candidates with assets less than 10 lakh won. The election results seemed to be highly influenced by the money power of the candidates.

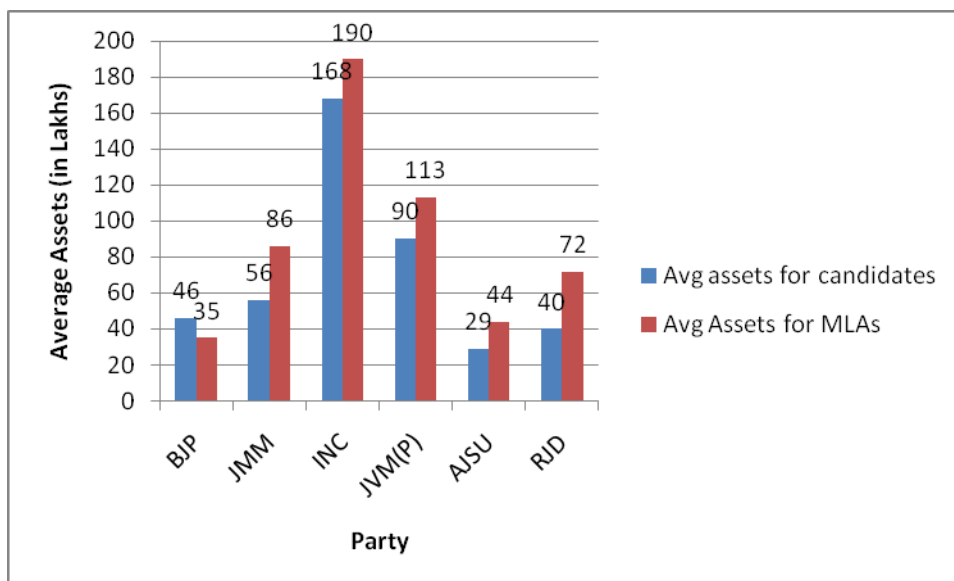


Figure: Comparison average assets for candidates & MLAs in Assembly 2009

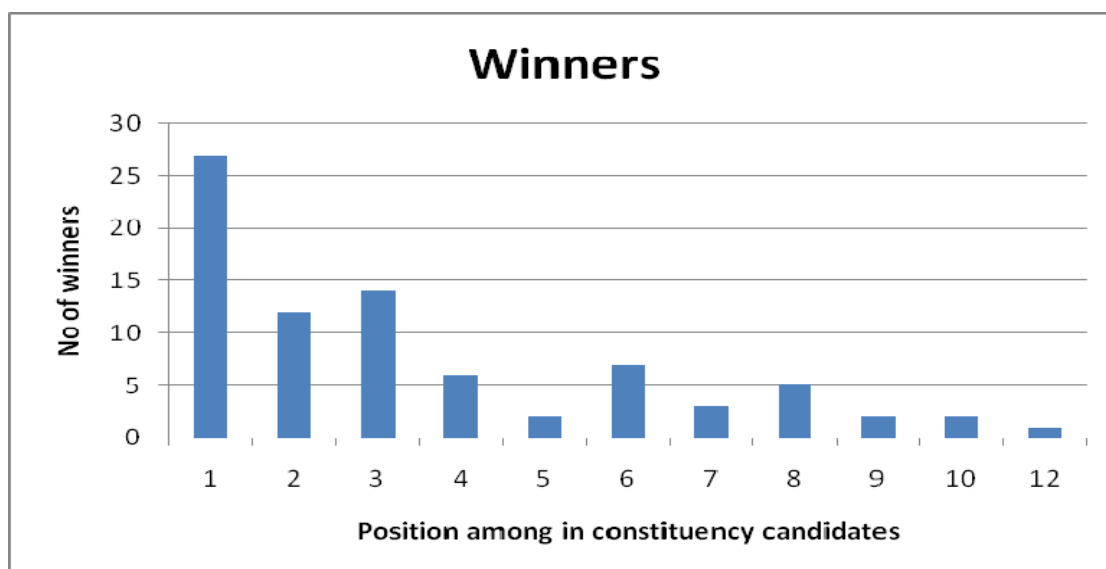


Figure: Asset position in constituency among candidates and winners
