कर्नाटक इलेक्शन वॉच और एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स ने कर्नाटक विधानसभा चुनाव 2023 में मुख्यमंत्री सहित 10 में से 9 मंत्रियों के शपथपत्रों का विश्लेषण किया। निर्वाचन क्षेत्र **सर्वगनानगर** से INC के 1 मंत्री **केलचंद्र जोसेफ जॉर्ज** का शपथपत्र स्पष्ट ना होने के कारण उनका विश्लेषण नहीं किया है।

यह जानकारी 2023 कर्नाटक विधानसभा चुनाव से पहले मंत्रियों द्वारा प्रस्तुत शपथपत्रों पर आधारित हैं।




