Summary and Highlights

Association for Democratic Reforms (ADR) and **Kerala Election Watch** have analysed the self-sworn affidavits of **20** out of **21** Ministers including Chief Minister, sworn in on **18th May 2026** for the **Kerala State Assembly**. **1 Communist Marxist Party Kerala State Committee** Minister namely **C P John** from **Thiruvananthapuram** constituency was not analysed due to an unclear affidavit uploaded on the ECI website at the time of making of this report.

The information is based on the affidavits submitted by the candidates prior to Kerala 2026 Assembly Elections.

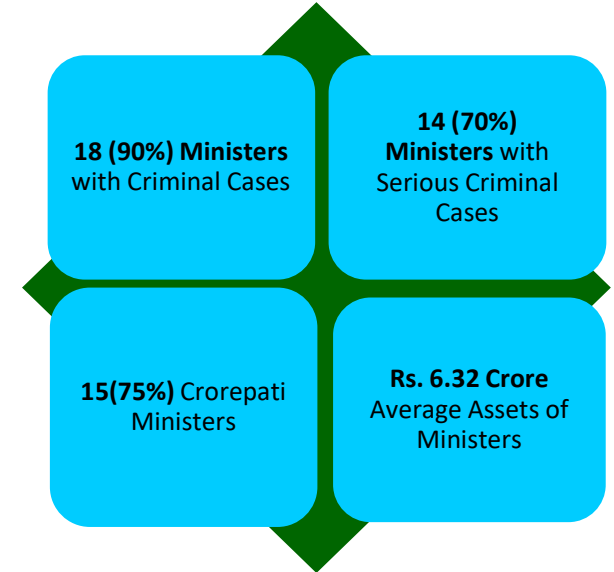
Criminal Background
