Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of **58** out of **62** Candidates who are contesting for the post of President in the **Pandharkavda, Chikkhaldhara, Kinwat, Navapur, Nandurbar, Hupari, Jat, Dahanu, Trimbak, Igatpuri & Jejuri** Municipal Council Elections, being held on **10th December, 13th December & 17th December, 2017** respectively, in Maharashtra. Rest of the affidavits from other local bodies are not analysed as they were not available at the time of making this report.

Criminal Background

- **Candidates with Criminal Cases:** **9 (16%)** out of **58** analyzed Candidates have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **6 (10%)** out of **58** analyzed Candidates have declared serious criminal cases against themselves like **attempt to murder, culpable homicide not amounting to murder, kidnapping, dacoity, criminal intimidation, forgery, cheating, etc.**
- **Party wise Candidates with declared Criminal Cases:** **3 (30%)** out of 10 Candidates from **Bhartiya Janata Party & 1 (14%)** out of 7 Candidates from **Shivsena** have declared criminal cases against themselves in their affidavits.

Criteria for serious criminal cases

1. *Offence for which maximum punishment is of 5 years or more.*
2. *If an offence is non-bailable*
3. *If it is an electoral offence (for eg. IPC 171E or bribery)*
4. *Offence related to loss to exchequer*
5. *Offences that are assault, murder, kidnap, rape related*
6. *Offences that are mentioned in Representation of the People Act (Section 8)*
7. *Offences under Prevention of Corruption Act*
8. *Crimes against women.*

- **Party wise Candidates with declared Serious Criminal Cases:** **2 (20 %)** out of 10 Candidates from **Bhartiya Janata Party** have declared serious criminal cases against themselves in their affidavits.

- **Crorepati Candidates:** Out of the **58** analyzed candidates, **20 (35%)** are crorepatis.
- **Party wise Crorepati Candidates:** **7 (70%)** out of 10 Candidates analyzed from **Bhartiya Janata Party**, **5 (50 %)** out of 10 Candidates analyzed from **Indian National Congress**, **3 (43%)** out of 7 candidates analyzed from **Shivsena** and **2 (40%)** out of **5** candidates analyzed from **Nationalist Congress Party** are crorepatis.

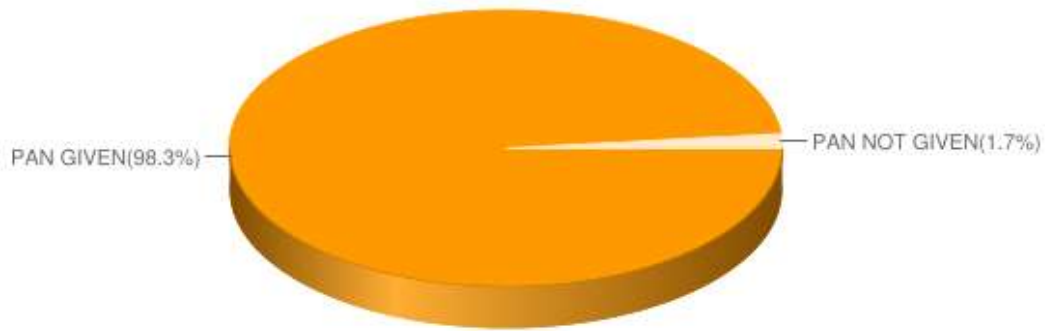

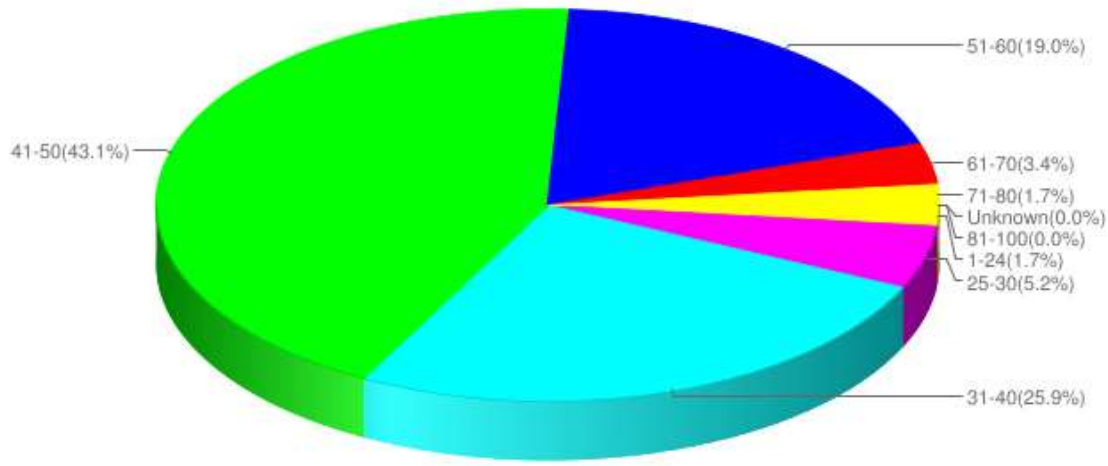

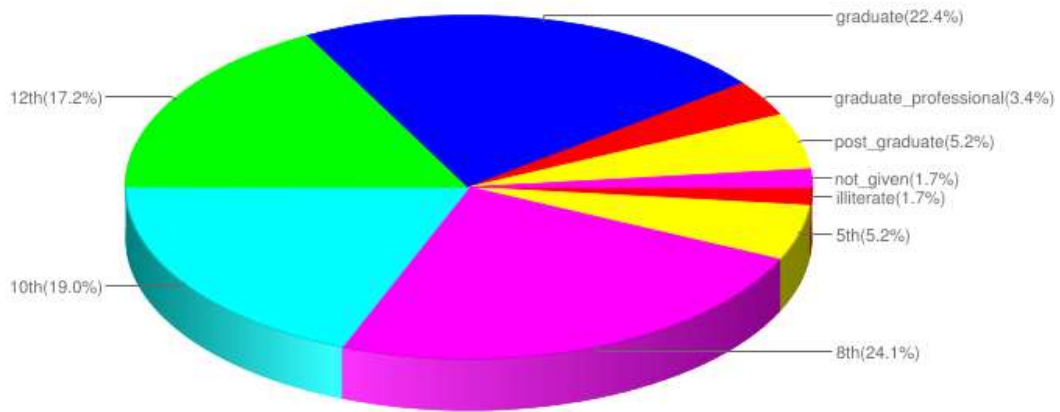

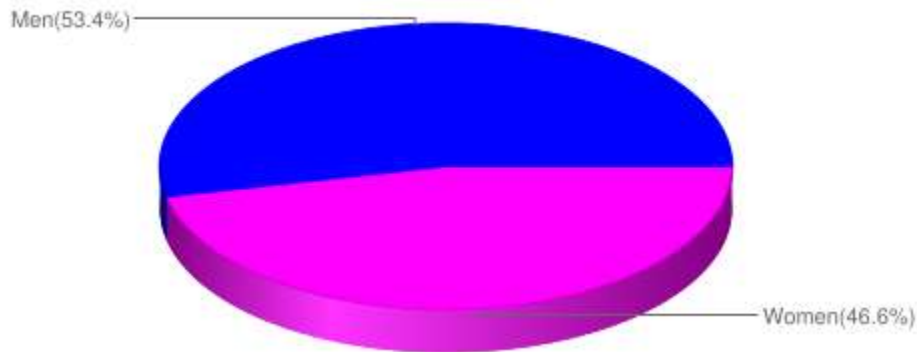
