### **Summary and Highlights**

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of all 9 winners who had contested in the Maharashtra Legislative Council Biennial Elections in May 2020. All candidates elected by MLAs have won unopposed.

#### **Criminal Background**

- Winners with declared Criminal Cases: 7 (78%) out of 9 analyzed winners have declared criminal cases against themselves.
- <u>Winners with declared Serious Criminal Cases:</u> 2 (22%) out of 9 analyzed winners have declared serious criminal cases against themselves like Rape, Murder, attempt to murder, etc.


#### Financial Background

- Offences that are mentioned in Representation of the People Act (Section 8)
- 7. Offences under Prevention of Corruption

- 8. Crimes against women.
