

## **Criminal Background**

- Candidates with Criminal Cases: Out of 74 candidates analyzed, 12(16%) candidates have declared criminal cases against themselves.
- <u>Candidates with Serious Criminal Cases:</u> 6(8%) candidates have declared serious criminal cases against themselves.

#### Criteria for serious criminal cases

- 1. Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- 3. If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- Offences that are assault, murder, kidnap, rape related
- 6. Offences that are mentioned in Representation of the People Act (Section 8)
- 7. Offences under Prevention of Corruption Act
- 8. Crimes against women.
