Criminal Background

- **Ministers with Criminal Cases:** 15(52%) ministers have declared criminal cases against themselves.
- **Ministers with Serious Criminal Cases:** 6(21%) ministers have declared serious criminal cases against themselves.
- **Ministers with declared cases related to murder:** 1 Minister, Sukhdev Panse of INC who elected from Multai Constituency of Betul district, declared 1 charge related to murder (IPC Section 302).

Financial Background

- **Crorepati Ministers:** Out of the 29 ministers, all 29 (100%) are crorepatis.
- **Average Assets:** The average assets of 29 ministers analysed is Rs 15.42 crores.
- **Ministers with Highest Assets:** The minister with the highest declared total assets is **Kamal Nath** from Chhindwara Parliamentary constituency Madhya Pradesh with assets worth Rs.206.90 crores. The top five ministers with highest declared assets are:
