Analysis of Criminal, Financial and Other Background details of Candidates from Madhya Pradesh(Phase-3)for Lok Sabha 2014

Association for Democratic Reforms (ADR) and Madhya Pradesh Election Watch have analyzed the self-sworn affidavits of 117 out of the 118 candidates contesting from Madhya Pradesh (Phase – 3) for Lok Sabha Election 2014 as given by the ECI.

The following candidate has not been analysed due to incomplete affidavit at the time of making this report:

Executive Summary – Phase 3

Criminal Background

- **Candidates with Criminal Cases:** Out of the 117 candidates analysed, **21 candidates (18%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 117 candidates, **10 (9%) candidates** have declared serious criminal cases relating to kidnapping, extortion etc.
- **Party wise Candidates with Criminal Cases:** INC has **5 (50%) out of 10**, AAP has **3 (30%) out of 10**, BJP has **1 (10%) out of 10** and BSP has **2 (20%) out of 10** candidates with declared criminal cases.
- **Party wise Candidates with Serious Criminal Cases:** AAP has **2 out of 10 (20%)**, INC has **2 out of 10 (20%)**, BSP has **2 out of 10 (20%)** candidates who declared serious criminal cases against themselves.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Candidates with cases related to Kidnapping:** Ramesh Chensingh, INC candidate from Khargone has a charge of **Kidnapping, abducting or inducing woman to compel her marriage, etc. (IPC Section-366)**
- **Red Alert Constituencies***: 4 constituencies in Madhya Pradesh (Phase – 3) have at least 3 candidates with declared criminal cases. Khandwa constituency has the most number of candidates i.e. 6 candidates with criminal cases.

*Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections (including independents)

Financial Background

- **Crorepati Candidates:** Out of the 117 candidates analysed, **23 (20%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **8 out of 10 (80%) INC** candidates are crorepatis, **8 out of 10 (80%) BJP** candidates, **1 out of 10 (10%) BSP** candidates and **2 out of 10 (20%) of AAP** candidates are crorepatis.
- **Average Assets:** The average assets per candidate contesting from Madhya Pradesh – Phase 3 in Lok Sabha 2014 elections is **Rs.2.23 crores**.
- **Party-wise Average Assets:** Among major parties, the average assets per candidate for **10 BJP** candidates was **Rs. 4.01 Crore**, for **10 INC** candidates was **Rs. 18.34 Crores**, for **10 BSP** candidates was **Rs. 31.65 lakhs**, for **10 AAP** candidates was **Rs. 1.02 crores**.
- **High Asset Candidates:** **9** candidates have declared more than **Rs.5 crore worth of assets**. Total assets include assets of self, spouse and others. Top 3 candidates with highest assets are:

Executive Summary – Phase 1 to 3

In total, affidavits of 370 candidates who contested the Lok Sabha elections from Madhya Pradesh (Phase 1 to 3) have been analyzed. The overall highlights are also below.

- **Total candidates analyzed: 370** candidates
- **Candidates with declared Criminal Cases so far: 65 (18%)** candidates
- **Candidates with declared Serious Criminal Cases: 35 (9%)** candidates
