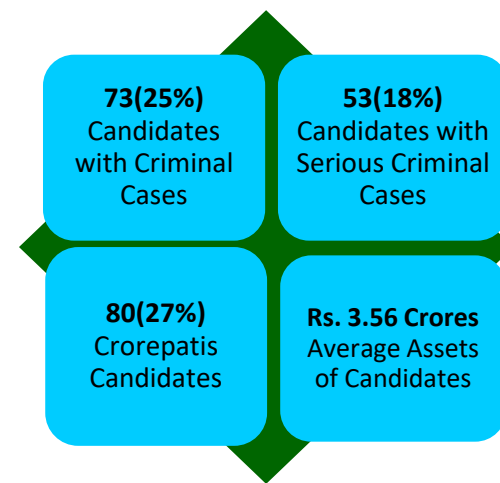

Summary and Highlights

Maharashtra Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of 296 out of 298 candidates, who are contesting in the following 11 constituencies in Maharashtra Phase-IV Lok Sabha elections 2024.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

There are 2 candidates who have not been analysed due to unavailability of their properly scanned and complete affidavits, at the time of making this report. The details of these 2 candidates are given below:

Criminal Background

- **Candidates with Criminal Cases:** Out of **296** candidates analyzed, **73 (25%)** candidates have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **53(18%)** candidates have declared serious criminal cases against themselves.
- **Candidates with cases related to Attempt to Murder:** **4** candidates have declared cases related to **attempt to murder (IPC Section 307)** against themselves.
- **Candidates with cases related to Crime Against Women:** **9** candidates have declared cases related to **crime against women**.
