## **Summary and Highlights**

Association for Democratic Reforms (ADR) and Manipur Election Watch have analyzed the criminal, financial and other background details of **53** out of **60** sitting MLAs. In current assembly 7 seats are vacant. This analysis is based on the affidavits submitted by the candidates prior to the 2017 Assembly elections and bye elections conducted thereafter.

The following is the list of constituencies where MLA seats are vacant:




#### **CRIMINAL BACKGROUND**

- <u>MLAs with criminal cases</u>: Out of **53** sitting MLAs analysed, **2 (4%) MLAs** have declared criminal cases against themselves.
- MLAs with serious criminal cases: 2 (4%) MLAs have declared serious criminal cases.
- <u>Party wise sitting MLAs with criminal cases:</u> 2 (7%) out of 29 MLAs from BJP have declared criminal cases against themselves in their affidavit.
- Party wise sitting MLAs with serious criminal cases: 2 (7%) out of 29 MLAs from BJP have declared serious criminal cases against themselves in their affidavit.

#### FINANCIAL BACKGROUND

- Crorepati MLAs: Out of 53 sitting MLAs analysed, 29 (55%) are crorepatis.
- <u>Party wise crorepati MLAs:</u> 15 (52%) out of 29 MLAs from BJP, 10 (67%) out of 15 MLAs from INC, 2 (67%) out of 3 MLAs from National Peoples Party and 2 (50%) out of 4 MLAs from Naga Peoples Front have declared assets valued more than Rs 1 crore.



#### Criteria for serious criminal cases

- 1. Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- 3. If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- 5. Offences that are assault, murder, kidnap, rape related
- 6. Offences that are mentioned in Representation of the People Act (Section 8)
- 7. Offences under Prevention of Corruption Act
- 8. Crimes against women.








Figure: Party Wise Percentage of Crorepati MLAs

- Average assets: The average of assets per sitting MLA is Rs.2.21 crore.
- <u>Party wise average assets</u>: The average assets per MLA for **29** BJP MLAs analysed is **Rs.1.63** crores, **15** INC MLAs analysed is **Rs.4.04** crores, **4** Naga Peoples Front MLAs analysed is **Rs.1.17** crores, **3** National Peoples Party MLAs analysed is **Rs.1.27** crores, **1** AITC MLA analysed is **Rs.57.47** lakhs and **1** Independent MLA has average assets of **Rs. 11.13** lakhs.

#### **OTHER BACKGROUND DETAILS**

- <u>Education Details of MLAs:</u> 11 (21%) MLAs have declared their educational qualification to be between 5<sup>th</sup> pass and 12<sup>th</sup> pass while 39 (74%) MLAs have declared having an educational qualification of graduate or above. 2 MLAs are Diploma Holders and 1 MLA is Illiterate.
- <u>Age details of MLAs:</u> 24 (45%) MLAs have declared their age to be between 25 and 50 years while 29 (55%) MLAs have declared their age to be between 51 and 80 years.
- Gender details of MLAs: Out of 53 MLAs analysed, 2 (4%) MLAs are women.




