



#### Analysis of Election Expenses of the newly Elected MLAs Manipur 2012

Association for Democratic Reforms (ADR) and National Election Watch (NEW), a nationwide campaign comprising of more than 1200 NGOs and other citizen led organizations, have been working on electoral reforms, improving democracy and governance in India. Election watch for each state has analyzed the abstract statement of expenses of MLAs who have won the 2012 State Assembly Elections. National Election Watch (NEW) analysed the abstracts of election expenses submitted by a total of 59 newly elected MLAs of Manipur.

This report is based on the analysis of the information provided by the MLAs and submitted to ECI. The Election Commission released expense abstract statements of the winners, first and second runners up of each state on the Chief Electoral Officer (CEO)'s website. In few cases where the abstract statement of the MLAs was not available, the summary sheet uploaded on the CEO's website which was instead uploaded has been used for taking information for our analysis.

#### **Summary of the Election Expenses – MLAs**

- NEW analyzed the election expenses declared by 59 newly elected MLAs out of 60 winners from 59 constituencies out of 60 constituencies.
- The Average Expense declaration of 59 MLAs is Rs 4, 20,369, which is 53% of the permissible limit of 8 Lac.
- Maximum expenses Rs 7,97,332 (7 Lacs+) have been declared by Yamthong Haokip of INC from Saikul(ST), Nemcha Kipgen of MSCP from Kangpokpi is second with expense declaration at Rs 7,95,400 and T. Manga Vaiphei of INC from Henglep (ST) third at Rs 7,02,974.
- The MLAs with lowest expense are Md. Abdul Nasir (INC, Lilong) Rs 1,45,532; K.
   Meghachandra (INC, Wangkhem) Rs 1,81,280; Paonam Brojen (MSCP, Wangjing Tentha) Rs 189,377.
- The average election expenses of the winners party wise show that average spending For INC 's candidates was Rs 4,26,305 (4 Lacs+), For AITC 's candidates was Rs 3,53,057 (3 Lacs+), For MSCP 's candidates was Rs 4,20,212 (4 Lacs+), For NPF 's candidates was Rs 4,82,614 (4 Lacs+), For NCP 's candidates was Rs 3,91,213 (3 Lacs+),.
- No MLA has shown expenses more than the expense limit.
- Only 2 MLAs have declared that they have utilized close to 100% of their permissible limit of 8
