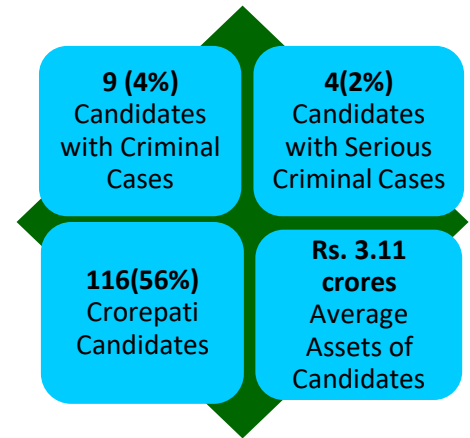

Summary and Highlights

The Mizoram Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of all 209 candidates, who are contesting in the **Mizoram Assembly Elections**. **Out of all 209 candidates, 84 are from national parties, 49 are from state parties, 13 are from registered unrecognized parties and 63 candidates are contesting independently.**

Most of the affidavits were submitted as per the new format specified vide ECI letter no. 3/42017SDR/Vol.II dated 10th October 2018. However out of 209 candidates analyzed, 8 candidates have still used the old format of the affidavit and 3 candidates have left some sections blank:

Criminal Background

- **Candidates with Criminal Cases:** Out of **209** candidates analyzed, **9 (4%)** candidates have declared criminal cases against themselves. In 2013 Mizoram Assembly Elections, out of **142** candidates analysed, **3(2%)** had declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of **9(4%)** candidates who have declared criminal cases, **4(2%)** have declared serious criminal cases. In 2013 Mizoram Assembly Elections, **2 (1%)** candidates had declared serious criminal cases against themselves.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act

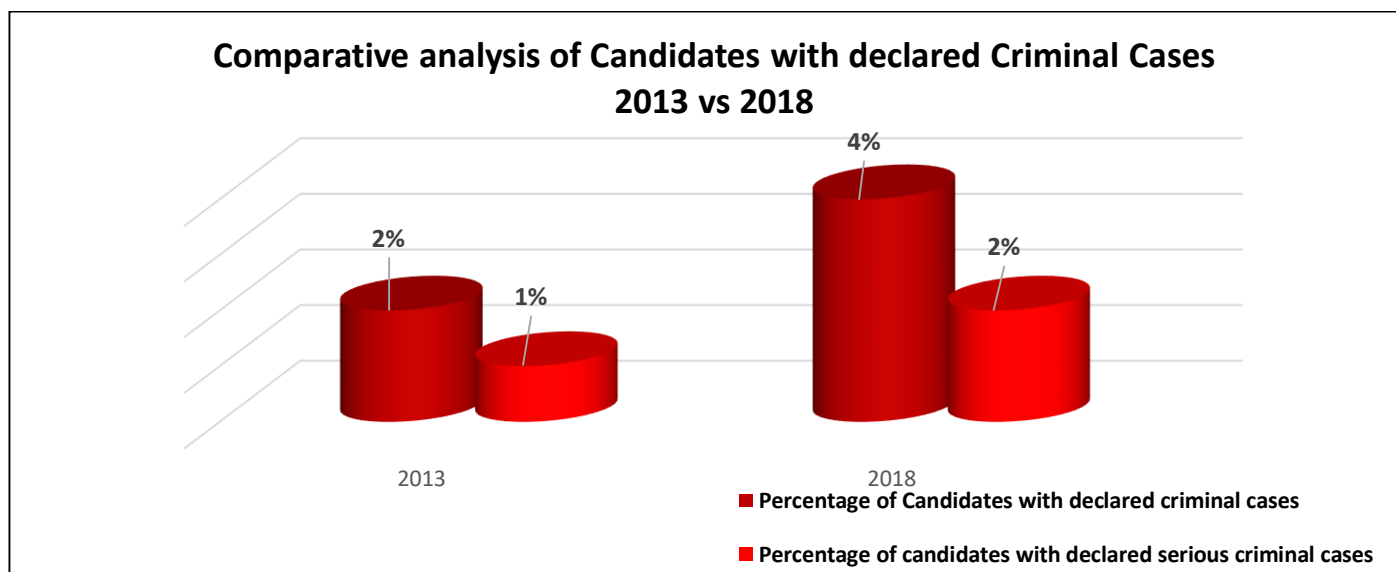


Figure: Comparative analysis of Candidates with declared Criminal Cases: 2013 vs 2018

- **Party wise Candidates with Criminal Cases:** Among the major parties, **2(5%)** out of 39 candidates from **Bharatiya Janta Party (BJP)**, **3(8%)** out of 40 candidates from **Indian National Congress (INC)**, **3 (8%)** out of 40 candidates from **MNF**, and **1 (2%)** out of 63 **Independent** candidates analysed have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** Among the major parties, **1(3%)** out of 39 candidates from **Bharatiya Janta Party (BJP)**, **2 (5%)** out of 40 candidates from **MNF**, and **1 (2%)** out of 63 **Independent** candidates analysed have declared serious criminal cases against themselves in their affidavits.

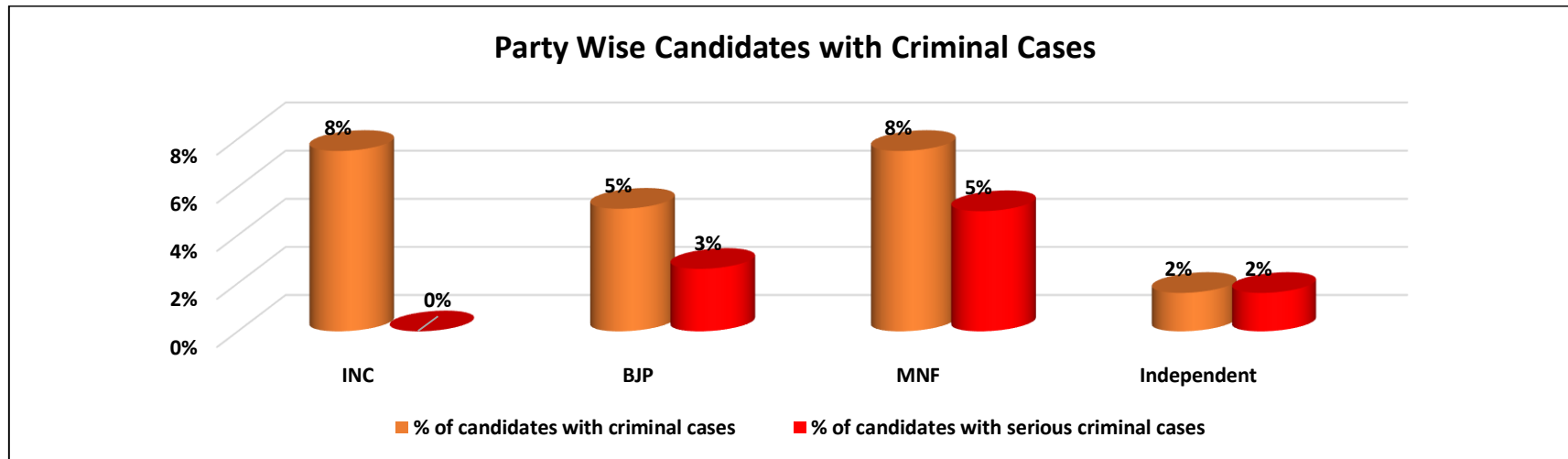


Figure: Party Wise Candidates with Criminal Cases

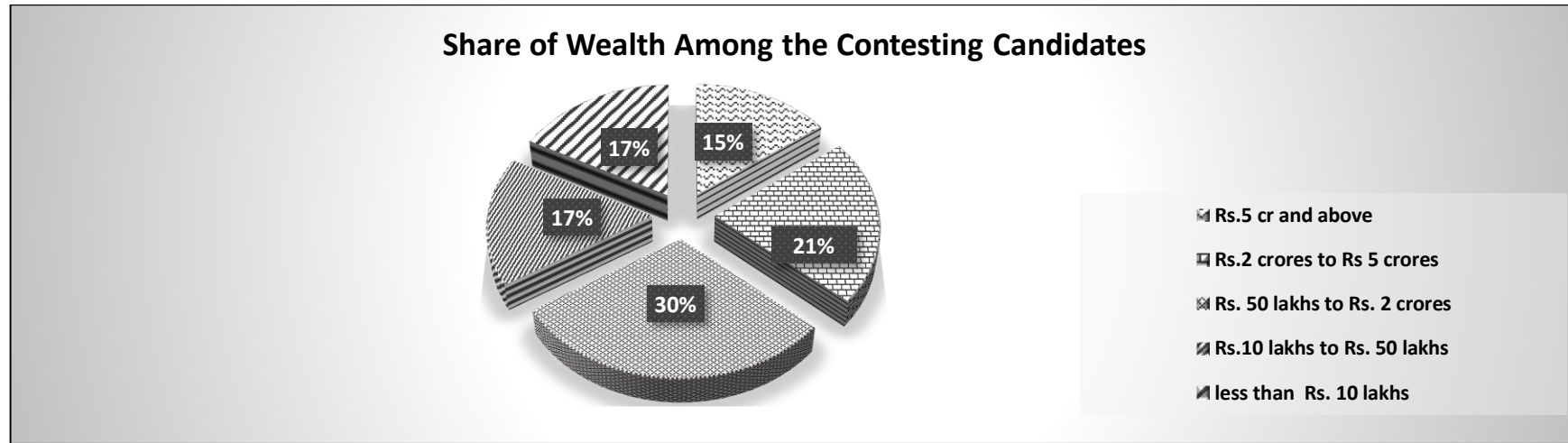


Figure: Share of Wealth among the Contesting Candidates

- **Crorepati Candidates:** Out of the **209** candidates, **116(56%)** are crorepatis. In 2013 Mizoram Assembly Elections, out of **142** candidates, **75 (53%)** were crorepatis.

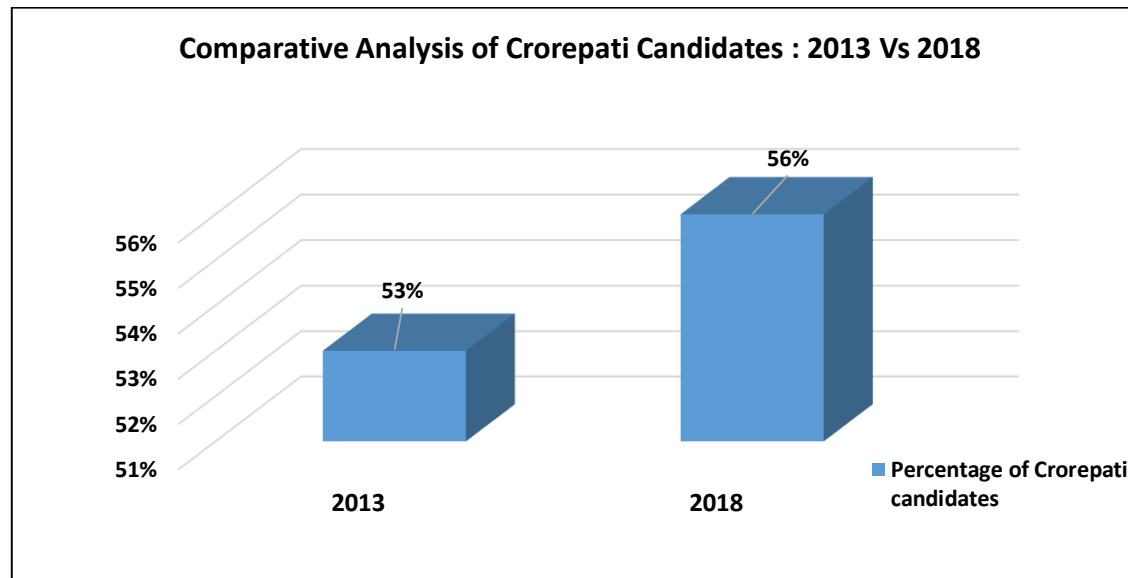


Figure: Comparative Analysis of Crorepati Candidates: 2013 Vs 2018

- **Party wise Crorepati Candidates:** Among the major parties **17(44%)** out of 39 candidates from **BJP**, **33(83%)** out of 40 candidates from **INC**, **35(88%)** out of 40 candidates from **MNF**, **5(56%)** out of 9 candidates from **NPP**, **2(15%)** out of 13 candidates from **Prism Party** and **24 (38%)** out of 63 **Independent** candidates have declared assets worth more than Rs. 1 crore.

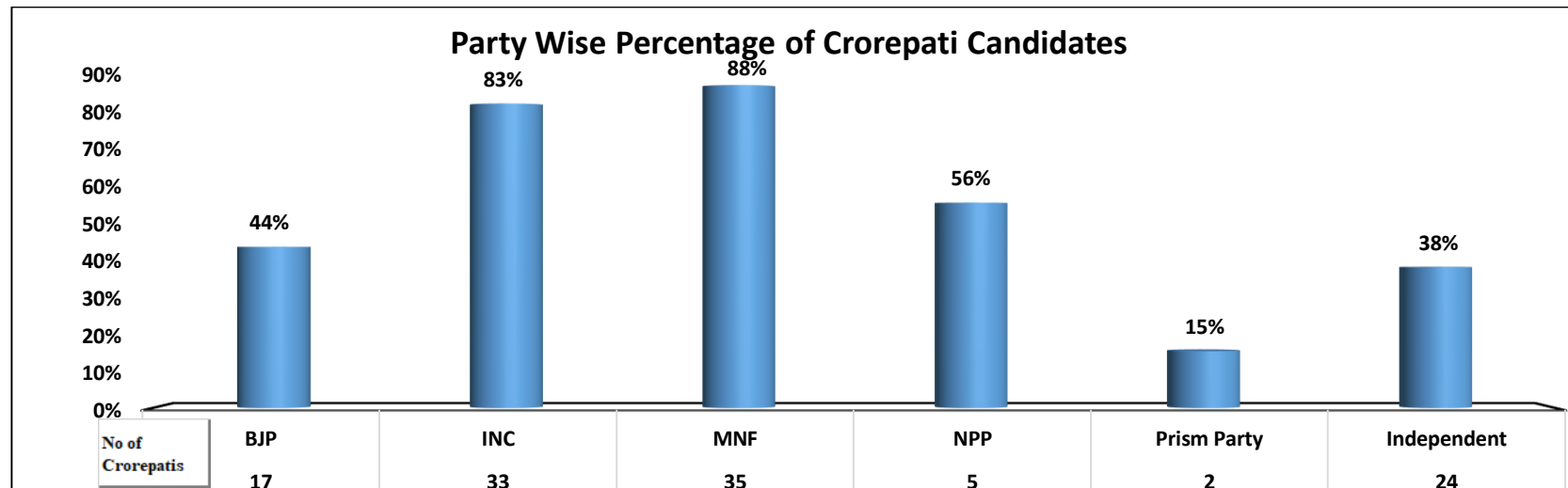


Figure: Party Wise Percentage of Crorepati Candidates

- **Average assets:** The average of assets per candidate contesting in the Mizoram Assembly Elections is **Rs 3.11 Crores**. In 2013 Mizoram Assembly Elections, average assets per candidate for 142 candidates was **Rs. 2.31 crores**.
- **Party wise average assets:** Among major parties, the average assets per candidate for **39 BJP** candidates is **Rs. 1.66 crores**, **40 INC** candidates is **Rs 3.31 crores**, **40 MNF** candidates have average assets of **Rs 7.21 crores**, **13 Prism Party** candidates have average assets worth **Rs 41.8 lakhs**, **9 NPP** candidates have average assets worth **Rs 1.73 crores**, **5 NCP** candidates have average assets worth **Rs 84.30 thousand** and **63 Independent** candidates have average assets of **Rs 2.29 crores**.

- **Sources of Income:** 15 out of 209 candidates have not declared their sources of income.

Other Background Details

- **Education details of candidates:** 60 (29%) candidates have declared their educational qualification to be between 5th and 12th, while 142 (68%) candidates have declared being a **graduate or above**. 1 candidate has declared to be just **literate** and 1 candidate is **illiterate**.
- **Age details of candidates:** 32(15%) candidates have declared their age to be between 25 and 40 years while 120 (57%) candidates have declared their age to be between 41 and 60 years. There are 56(27%) candidates who have declared their age to be between 61 and 80 years. 1 candidate has declared his age to be **above 80 years**.
- **Gender details of candidates:** 18(9%) female candidates are contesting in the **Mizoram assembly election this year**. In 2013 Mizoram Assembly Elections, 6(4%) out of 142 candidates analysed were women.

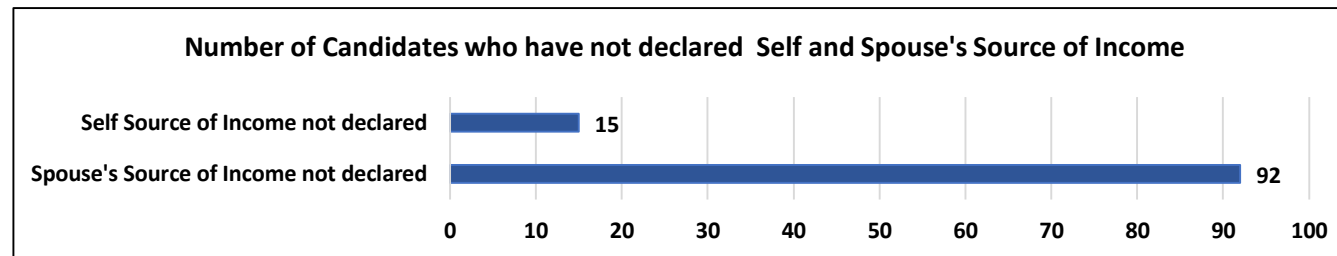
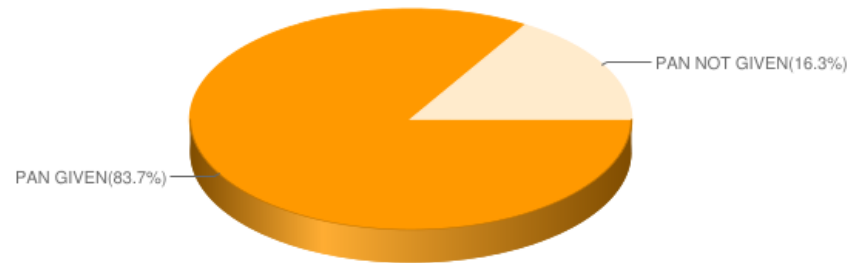


Figure: Candidates who have not declared sources of Income

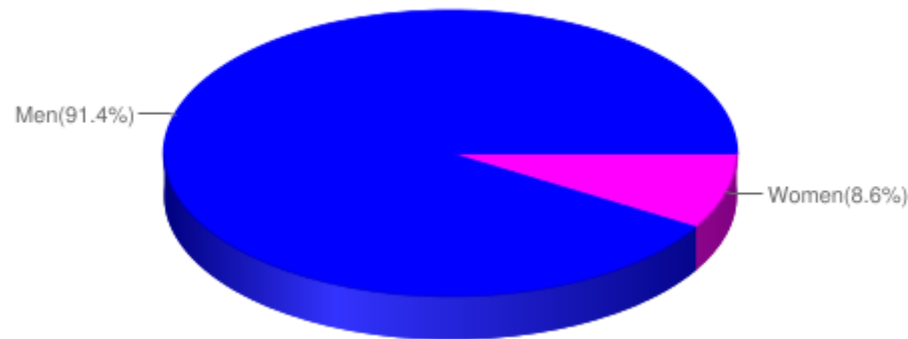
