

# Analysis of Election Expenses of MLAs from the Nagaland 2013 Assembly Elections

**Contesting candidates have to file their election expenses within 30 days from the date of declaration of result of election.**

The maximum limit put on these Election Expenses for the Nagaland 2013 Assembly Elections by the Election Commission of India is 8 Lakh Rupees.

National Election Watch (NEW) and Association for Democratic Reforms (ADR) have analyzed the election expenditure documents of all 60 newly elected MLAs in the Nagaland 2013 Assembly Elections. These election expense documents include *details of expenses on public meeting and processions, campaigning through electronic and print media, expense on campaign workers, expense on vehicles used and expense on campaign materials.*

## Summary and Highlights

1. **Average Election Expenses:** Based on the election expense declarations of 60 newly elected MLAs of Nagaland to the ECI, the average amount of money spent by them in the elections is only about Rs 4.62 Lakhs, which is 58% of the expense limit (8 Lakhs).
2. **Party wise Average Election Expenses:** The Party wise average election expenses shows that the average spending for 38 MLAs of NPF was Rs 4.53 lakhs (57% of the expense limit), for 8 MLAs of INC was Rs 4.95 lakhs (62% of the expense limit), for 4 MLAs of NCP was Rs 3.67 lakhs (46% of the expense limit), for 1 MLA of JD(U) was Rs 7 Lakhs (88% of the expense limit), for 1 MLA of BJP was Rs. 1.47 Lakhs (19% of the expense limit) and for 8 Independent MLAs was Rs 5.30 Lakhs (66% of the expense limit).
3. **Top 3 MLAs with highest Election Expenses:** The maximum expense of Rs. 7.63 lakhs (95 % of the expense limit) has been declared by N Thomas Lotha an Independent MLA from Sanis constituency, followed by T Myingthungo Lotha of NCP from Wokha constituency with an expense of about Rs. 7.36 lakhs (92% of the expense limit) and Namri Nchang of NPF from Tenning constituency with an expense of Rs. 7.19 lakhs (90% of the expense limit).
4. **High Election Expenses:** 18 MLAs have declared election expenses of more than 5 Lakh Rupees and only 5 other MLAs has declared expenses of 7 Lakh Rupees and more.
5. **Lowest Election Expenses Declared:** A total of 9 MLAs have declared election expenses less than Rs 3 lakhs (that is about 38 % of Expense Limit set by ECI).
6. **MLAs with lowest Election Expenses:** The minimum expense of about Rs 1.10 Lakhs (14% of the expense limit) has been declared by Kropol Vitsu of NPF from Southern Angami-II constituency. He is followed by P.Paiwang Konyak of BJP from Tizit constituency who has declared election expenses worth Rs. 1.47 Lakhs (18% of the expense limit) and Yitachu of NPF from Meluri constituency with election expenses of Rs. 2.01 lakhs (25% of the expense limit).
7. **Expense on Public Meetings and Processions:** Out of all the 60 MLAs whose election expenditure documents have been analyzed, 16 MLAs have declared that they have spent not spent ANY amount on public meetings, processions etc and 16 others, have declared that they have spent less than Rs 20,000 on public meetings and processions.
8. **Expense on Campaigning through electronic/print media:** 36 MLAs have declared that they have not spent ANY amount on campaigning through electronic/print media. 17 other MLAs have declared that they have spent less than Rs 10,000 on campaigning through electronic/print media.
9. **Expense on Campaign Workers:** 24 MLAs have declared that they have not spent ANY amount on campaign workers. 8 other MLAs have declared that they have spent less than Rs 30,000 on campaign workers.

10. **Expense on Vehicles Used:** 11 MLAs have declared that they have spent less than Rs 70,000 on use of vehicles. 13 other MLAs have declared they have spent over Rs 2 Lakhs on use of vehicles.
11. **Expense on Campaign Materials and Erection of gates, arches, banners etc.:** 11 MLAs including Chief Minister Neiphiu Rio of NPF from Northern Angami-II constituency have declared that they have not incurred any expense on campaign materials and erection of gates, arches, banners etc. 16 other MLAs have declared that they have spent less than Rs 20,000 on campaign materials and erection of gates, arches, banners etc.

## Average expenses declared by MLAs - party-wise

The average election expense party wise shows that the average spending for 8 MLAs of INC was Rs 4.95 lakhs (62% of the expense limit), for NPF's 38 MLAs was Rs 4.53 lakhs (57% of the expense limit), for 4 MLAS of NCP was Rs 3.67 lakhs (46% of the expense limit), for 1 MLA of JD(U) is Rs 7 lakh(88% of the expense limit), for 1 MLA of BJP is Rs. 1.47 Lakhs (19% of the expense limit) and for 8 Independent MLAs is Rs 5.30 Lakhs (66% of the expense limit)

The maximum expense of Rs. 7.63 lakhs (95 % of the expense limit) has been declared by N Thomas Lotha an Independent MLA from Sanis constituency, followed by T Myingthungo Lotha of NCP from Wokha constituency with an expense of about Rs. 7.36 lakhs (92% of the expense limit) and Namri Nchang of NPF from Tenning constituency with an expense of Rs. 7.19 lakhs (90% of the expense limit). ## 5 lowest election expenses declared by MLAs

The minimum expense of about Rs 1.10 Lakhs (14% of the expense limit) has been declared by Kropol Vitsu of NPF from Southern Angami-II constituency. He is followed by P.Paiwang Konyak of BJP from Tizit constituency who has declared election expenses worth Rs. 1.47 Lakhs (18% of the expense limit) and Yitachu of NPF from Meluri constituency with election expenses of Rs. 2.01 lakhs (25% of the expense limit).

## MLAs who declared NO expenses on Public Meetings, Processions etc.

According to the ECI's document of Election Expenditure Monitoring 2011, (5.5.1) *Any candidate or his representative, who applies for permission for a public meeting or a rally shall also submit an expenditure plan in a prescribed format along with the application for permission.* (5.6.2) *In the event of public rally or meeting by the star campaigner, if the candidate or his election agent shares the dias with the star campaigner/another dignitary or banners and posters with his name or photograph are displayed at the site of the rally or his name is mentioned by the Star Campaigner, then the entire expenditure on that rally other than the travel expenses on that star campaigner shuld be added to the candidate's expenses.*

Out of all the 60 MLAs whose election expenditure accounts were analyzed, 16 declared that they had not spent ANY amount on public meetings, processions etc. as per their election expenses. Their names are listed below:

## MLAs who declared NO expense on campaigning through electronic/print media

This category for monitoring election expenses is mainly to combat instances of “paid news” and surrogate advertising that many candidates resort to. According to 4.10.4 of ECI’s document of Election Expenditure Monitoring 2011, “The candidate will have to submit the details of expenditure on the telecast/ broadcast in electronic media and advertisement/ paid news in print media. If the Media monitoring cell finds that any advertisement has been published in favour of any candidate without proper permission, they shall inform the RO immediately, and the RO will issue a notice to the candidate u/s 127 of the R.P.Act, 1951”.

36 MLAs have declared that they have not spent ANY amount on campaigning through electronic/print media. The table below provides a list of the names of these MLAs.

The R.O. will issue permits for use on the same day. The vehicle permit obtained from the concerned RO is to be displayed on the front screen of the vehicle..."
