Criminal Background

- <u>Candidates with Criminal Cases</u>: Out of 40 candidates analyzed, 12 (30%) candidates have declared criminal cases
 against themselves.
- <u>Candidates with Serious Criminal Cases:</u> **8(20%) candidates** have declared serious criminal cases against themselves.
- <u>Candidates with cases related to Murder:</u> 1 candidate has declared cases related to murder (IPC Section -302) against himself.
- <u>Candidates with cases related to Attempt to Murder:</u> 4 candidates have declared cases related to attempt to murder (IPC Section 307) against themselves.
- <u>Candidates with cases related to Crime Against Women:</u> 4 candidates have declared cases related to crime against women.

Criteria for serious criminal cases

- 1. Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- 5. Offences that are assault, murder, kidnap, rape related
- Offences that are mentioned in Representation of the People Act (Section 8)
- 7. Offences under Prevention of Corruption Act
- 3. Crimes against women.
