Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of all **78** winners who had contested in the **20** multi member wards of the **Panvel Municipal Corporation** Elections, held on **24th May, 2017**.

Criminal Background

- **Winners with Criminal Cases:** **17 (22%)** out of **78** analyzed winners have declared criminal cases against themselves.
- **Winners with Serious Criminal Cases:** **12 (15%)** out of **78** analyzed winners have declared serious criminal cases against themselves like **attempt to murder, kidnapping, criminal intimidation, cheating, etc.**
- **Party wise Winners with declared Criminal Cases:** **15 (29%)** out of 51 winners from **Bhartiya Janta Party (BJP)** and **2 (9%)** out of 23 winners from **Bhartiya Shetkari Kamgar Paksh** have declared criminal cases against themselves in their affidavits.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Party wise Winners with declared Serious Criminal Cases:** **11 (22%)** out of 51 winners from **Bhartiya Janta Party (BJP)** and **1 (4%)** out of 23 winners from **Bhartiya Shetkari Kamgar Paksh** have declared serious criminal cases against themselves in their affidavits.

- **Party wise Crorepati Winners:** **40 (78%)** out of **51** winners analysed from **BJP**, **17 (74%)** out of **23** winners analysed from **Bhartiya Shetkari Kamgar Paksh**, **2 (100%)** out of **2** winners analysed from **NCP** and **1 (50%)** out of **2** winners analysed from **INC**, are Crorepatis.

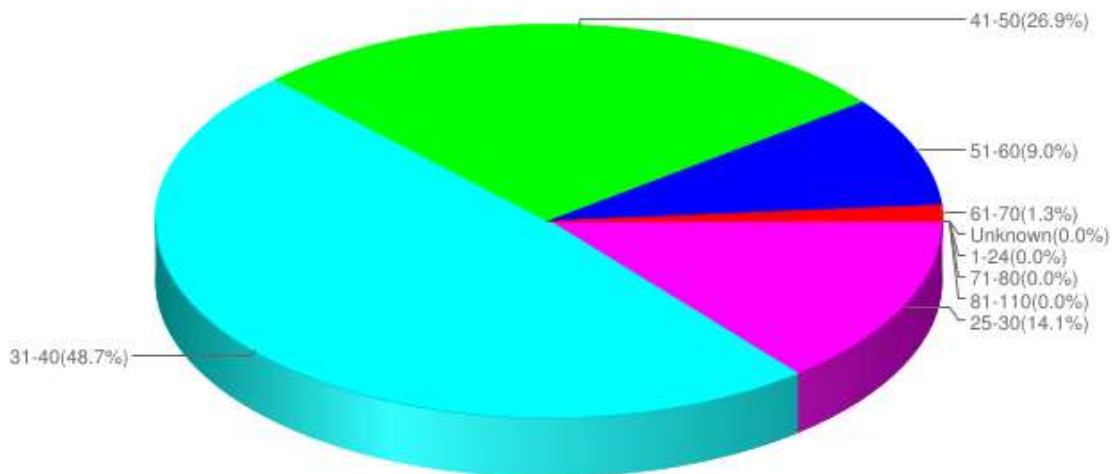

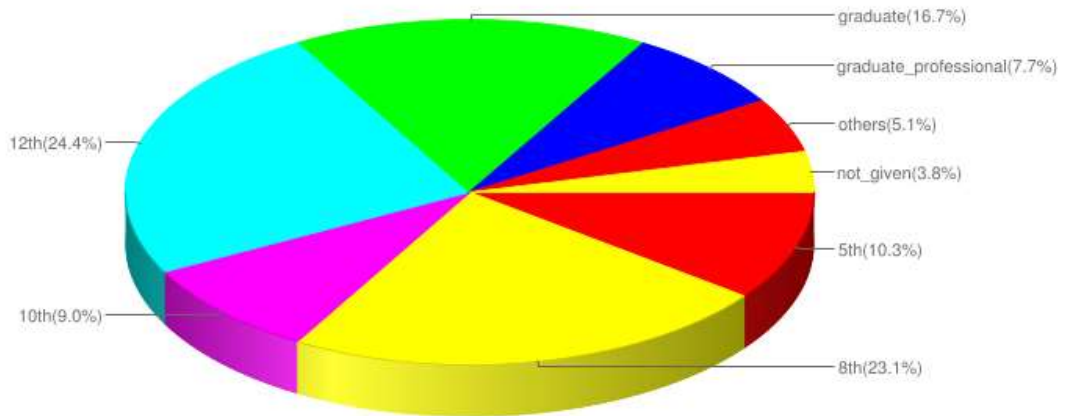

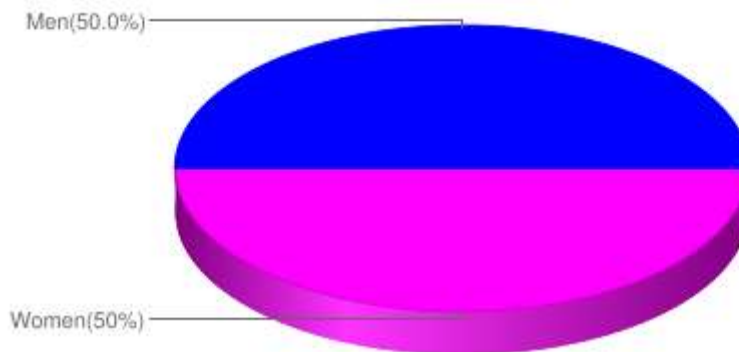
