



. Share of Corporate & Individual Donors who purchased Electoral Bonds,

12 April 2019 to 15 February 2024

Out of the total **18,871** bonds purchased between 12.04.2019 and 15.02.2024, **16,631** were purchased by **corporate/business houses** and **2,240 bonds** were purchased by **individuals.**

During this period, corporate/business houses purchased a total amount of Electoral Bonds worth Rs 11,780.0297 cr (96.91%) while individuals donated Electoral Bonds worth Rs 375.4835 cr (3.09%). Together this amounted to 18,871 bonds worth Rs 12,155.5132 cr.

II. Top 25 corporate donors who contributed through Electoral Bonds between

12 April 2019 to 15 February 2024

The top 25 donors of Electoral Bonds to political parties include all corporates and business houses only. Future Gaming & Hotel Services Private Limited purchased the highest amount of Electoral Bonds worth Rs 1368 cr having the maximum share of 11.254%. This is followed by Megha Engineering & Infrastructures Limited which purchased 966 bonds worth Rs 966 cr (having a share of 7.947%).

Together the **top 25 donors** contributed **6658 bonds** worth **Rs 6312.67 cr (51.93%)** to political parties between 12 April 2019 and 15 February 2024.
