## **Analysis of Criminal, Financial and Other Background details of Candidates from Kerala for Lok Sabha 2014**

Association for Democratic Reforms (ADR) and Kerala Election Watch (KEW) have analyzed the self-sworn affidavits of 256 candidates out of 269 contesting candidates from Kerala for Lok Sabha Election 2014 election as given by the ECI.

## Executive Summary

### Criminal Background

- **Candidates with Criminal Cases:** Out of the 256 candidates analysed, **74 candidates (29%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 256 candidates, **31 candidates (12%)** have declared serious criminal cases including murder.
- **Candidates with multiple serious IPC counts:** A total of 19 candidates have declared multiple serious IPC counts of which **Abdul Jabbar K K of SDPI from Kannur Constituency** has declared the highest count of **serious IPC charges i.e. 9** followed by **M B Rajesh of CPI(M) from Palakkad constituency** with 5 serious IPC charges and **Das K Varkala, Independent from Attingal constituency**, with 5 serious IPC charges.
- **Party wise Candidates with Criminal Cases:** Out of these 256 candidates analyzed, **SDPI has 14 out of 20 (70 %)**, **BJP has 7 out of 17 (41 %)**, **CPI(M) has 6 out of 9 (67 %)**, **INC has 6 out of 15 (40 %)**, **CPI has 4 out of 4 (100 %)**, **BSP has 3 out of 20 (15 %)** candidates with declared criminal cases.
- **Party wise Candidates with Serious Criminal Cases:** Out of the 31 (12 %) candidates who has declared serious criminal cases, **SDPI has 7 (35%)**, **BJP has 4 (24%)**, **INC has 2 (13%)**, **BSP has 2 (10%)**, **CPI has 2 (50%)** and **CPI(M) has 1 (11.1%)** candidate who declared serious criminal cases against themselves, including murder and attempt to murder.
- **Candidates with cases related to Murder :** 9 candidates have declared cases related to murder and attempt to murder.
- **Red Alert Constituencies\***: 11 out of 20 constituencies in Kerala have at least 3 candidates with declared criminal cases.  
*\*Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections. This analysis excludes independent candidates with criminal cases.*

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

### Financial Background

- **Crorepati Candidates:** Out of the 256 candidates analysed, **46 (18%)** are crorepatis.
- **Party-wise Crorepati Candidates:** Of all the 46 crorepati candidates, **INC has 8(53.3%)**, **AAP has 4(27%)**, **BJP has 2(12%)** and **CPI(M) has 2 (22%)** crorepatis.
- **Average Assets:** The average assets per candidate contesting from Kerala in Lok Sabha 2014 elections is **Rs. 82.21 lakhs**
- **Party-wise Average Assets:** Among major parties, the average assets of **9 CPI(M) candidates is Rs. 70.58 lakhs**, of **20 SDPI candidates is Rs. 50.92 lakhs**, of **17 BJP candidates is Rs. 50.65 lakhs**, for **15 candidates of**

INC is Rs. 2.61 crores, for 4 candidates of CPI is Rs 1.53 crores and for 15 candidates of AAP, it is Rs. 3 crores.

- **High Asset Candidates:** 6 candidates have declared more than Rs. 5 crores worth of assets. Total assets include Self Assets and Others' Assets. The top three candidates with highest assets are given below:

- **Low Asset Candidates:** Out of 256 candidates analysed, a total of 57 candidates have declared assets less than Rs 3 Lakhs, among which 4 have declared 0 assets; they are Rajesh S of SHS from Palakkad, Soman Pillai of Indian Gandhian Party from Thrissur, Chandrababu who is an Independent from Alappuzha and Syamalakumari who is also an independent candidate from Thiruvananthapuram. The three candidates with lowest assets are as follows:

- **Candidates who have not given value for Immovable Assets:** 30 candidates out of 256 candidates analysed have not given value for atleast 1 immovable assets that they have declared in their affidavits.
- **Candidates who have dues to Government Departments:** 1 candidate, Mathew T Thomas of JD(S) from Kottayam has declared a total of Rs. 3.27 lakhs dues to various Government departments
- **Candidates with Liabilities:** A total of 125 candidates out of 256 analyzed have declared liabilities out of which 18 candidates have declared liabilities above Rs 20 lakhs. Top 3 candidates with highest liabilities: Adv.Joice George, Independent candidate from Idukki constituency has declared total liabilities of Rs. 94.17 lakhs, M I Shanavas of INC from Wayanad has declared total liabilities of Rs. 77.11 lakhs and P C Jolly, Independent candidate from Idukki has declared 55 lakhs as total liabilities.
- **Candidates with High Income:** A total of 88 candidates have declared their income tax details out of which 22 candidates have declared a total income of more than Rs 10 lakhs. Anitha Prathap of AAP from Ernakulam has declared a total income of Rs. 1.07 crores, Dr. Shashi Tharoor, INC candidate from Thiruvananthapuram has declared a total income of Rs. 75.40 lakhs and P C Chako of INC from Chalakyud has declared a total income of Rs. 28.20 lakhs in the ITR. \*Total income includes income of self, spouse and dependents
- **Candidates who have not declared Income Tax Details\*:** 168 (66%) candidates out of 256 analyzed have not declared income tax details. \* Some candidates may be exempted from filing Income Tax Returns
- **Candidates with High Assets who have not declared Income Tax Details:** 26 candidates out of 256 analysed have declared asset value of more than Rs 50 lakhs but have not declared Income Tax Details.
- **Undeclared PAN:** 115 (45%) out of 256 candidates analysed have not declared their PAN details.

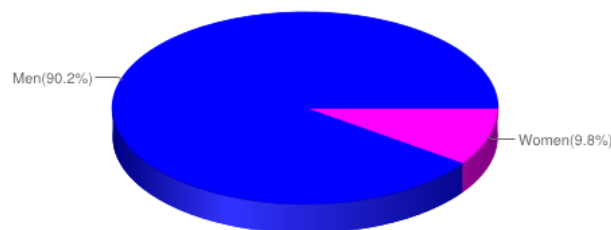
