## **Analysis of Criminal, Financial and Other Background details of Candidates from Goa for Lok Sabha 2014**

Association for Democratic Reforms (ADR) and Goa Election Watch have analysed the self-sworn affidavits of all 19 contesting candidates from 2 constituencies of Goa for Lok Sabha Election 2014 as given by the ECI.

## Executive Summary – Phase 4

### Criminal Background

- **Candidates with Criminal Cases:** Out of the 19 candidates analysed, **6 candidates (32%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 19 candidates, **3 candidates** have declared serious criminal cases relating to **wrongful confinement, criminal intimidation, voluntarily causing hurt by weapons**, etc.
- **Candidates with multiple serious IPC counts:** All **3 candidates** with declared serious cases have multiple counts of serious IPC charges. **Dayanand G. Narvekar**, an Independent candidate from North Goa constituency has declared **4 counts of serious IPC charges** followed by **Govind Gaude**, also an Independent candidate from South Goa constituency with **3 counts of serious IPC charges** and **Churchill Alemao** of AITC from South Goa constituency has declared **3 counts of serious IPC charges**.

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

**Red Alert Constituencies\***: 1 out of the 2 constituencies in Goa have at least 3 candidates with declared criminal cases from political parties.

### Financial Background

- **Crorepatis Candidates:** Out of the 19 candidates analysed, **7 (37%)** are crorepatis.
- **Average Assets:** The average assets per candidate contesting from Goa in Lok Sabha 2014 elections is **Rs. 5.97 crores**.
- **High Asset Candidates:** **7** candidates have declared more than **Rs. 1 crore worth of assets**. Total assets include Self Assets and Others' Assets. The top three candidates with highest assets are given below:

- **Candidates with Liabilities:** A total of 12 candidates out of 19 analyzed have declared liabilities out of which 3 candidates have declared liabilities above Rs 50 lakhs. Churchill Alemao of AITC from South Goa constituency has declared liabilities of Rs. 7.25 crores followed by Dayanand G. Narvekar, an Independent candidate from North Goa constituency with liabilities of Rs 6.29 crores and Raju Dsouza of Samajwadi Janata Party (Rashtriya) from North Goa constituency with liabilities of Rs 50.50 lakhs
- **Candidates with High Income:** A total of 16 candidates have declared their income tax details out of which 4 candidates have declared a total income of more than Rs 10 lakhs. Dayanand G. Narvekar, an Independent candidate from North Goa constituency has declared the highest total income of Rs 74.88 lakhs followed by Churchill Alemao of AITC from South Goa constituency with a total income of Rs 62.28 lakhs, Shripad Yesso Naik of BJP with a total income of Rs. 11.02 lakhs and Aleixo Reginaldo Lourenco of INC from South Goa with a total income Rs. 10.05 lakhs. \* Total income includes income of self, spouse and dependents
- **Candidates who have not declared Income Tax Details\*:** 3 (16%) out of 19 candidates analysed have not declared his income tax details. \* Some candidates may be exempted from filing Income Tax Returns

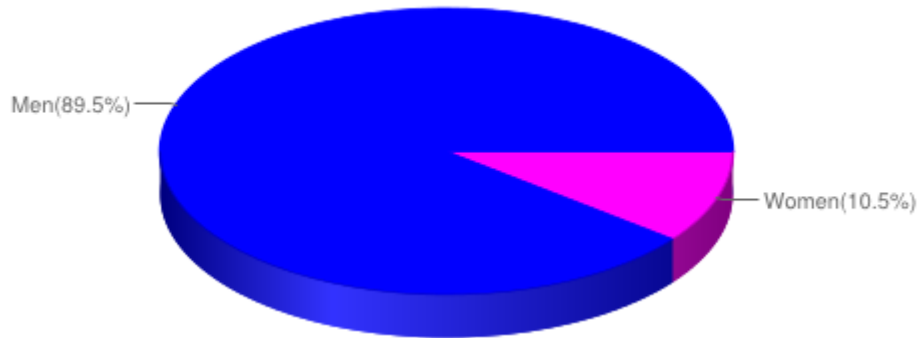
