## **Analysis of Criminal, Financial and Other Background Details of Candidates from Bihar (Phase – 2) for Lok Sabha 2014**

Association of Democratic Reforms (ADR) and Bihar Election Watch have analyzed the self-sworn affidavits of 116 out of the 117 candidates (as given by the ECI) who are contesting the 2<sup>nd</sup> Phase of Lok Sabha 2014 elections in Bihar.

## Executive Summary

### Criminal Background

- **Candidates with Criminal Cases:** Out of 116 candidates analysed, **30 candidates (26%)** have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** Out of 116 candidates analyzed, **23 candidates (20%)** have declared serious criminal cases including cases related to **murder, attempt to murder, criminal intimidation, theft etc.**
- **Party wise Candidates with Criminal Cases:** **3 (43%)** out of **7** candidates fielded by **BSP**, **2 (29%)** out of **7** candidates from **JD(U)**, **3 (60%)** out of **5** candidates of **RJD**, and **2 (50%)** out of **4** candidates from **BJP**, **4 (80%)** out of **5** candidates from **CPI(ML)L** and **6 (19%)** out of **32 Independent candidates** have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** **3 (43%)** out of **7** candidates fielded by **BSP**, **2 (29%)** out of **7** candidates from **JD(U)**, **3 (60%)** out of **5** candidates from **RJD**, **3(60%)** out of **5** candidates from **CPI(ML)L** and **5 (16%)** out of **32 Independent candidates** have declared serious criminal cases against themselves in their affidavits.
- **Candidates with cases related to Murder:** **3 candidates** have declared charges related to **murder(IPC Section-302)**
- **Candidates with cases related to Attempt to Murder:** **8 candidates** have declared charges related to **attempt to murder (IPC Section-307)** out of these, **3 candidates have both, charges of murder and attempt to murder declared against themselves.**
- **Candidate with Crimes against Women:** **2 candidates** have declared a charges related to crimes against women. **Uchit Kumar** an Independent candidate from Munger constituency has declared a charge related to **assault or criminal force to woman with intent to outrage her modesty (IPC Section-354)** and **Manju Devi** of Krantikari Vikas Dal from Jahanabad constituency declared a case related to **dowry death (IPC section 304B)**
- **Red Alert Constituencies\*:** **6 constituencies** have atleast 3 candidates with declared criminal cases.  
*\*Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections.*

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

### Financial Background

- **Crorepati Candidates:** Out of the 116 candidates analysed, **33 (29%)** are crorepatis.
- **Party-wise Crorepati Candidates:** **All 4 candidates** from **BJP**, **all 7 candidates** from **JD(U)**, **both candidates** fielded by **INC** and **LJP** respectively, **3(60%)** out of **5** candidates from **RJD** and **3(43%)** out of **7** candidates from **AAP** have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting in the second phase of elections from Bihar for Lok Sabha 2014 is **Rs.9.72 crores.**

- **Party-wise Average Assets:** Among major parties, the average assets for 7 JD(U) candidates is **Rs 126.47 crores**, 4 BJP candidates have average assets of **Rs.35.04 crores**, 2 INC candidates have average assets of **Rs. 7.27 crores**, 5 RJD candidates have average assets of **Rs. 2.63 crores** while 2 LJP candidates have average assets of **Rs. 2.19 crores**.
- **High Asset Candidates:** 11 candidates out of the 116 analyzed have more than **Rs.5 crore worth of assets**. Total Assets includes Self Assets and Others Assets. The top three candidates with highest assets are given below:

- **Low Asset Candidates:** Out of the 116 contesting candidates analyzed, a total of **13** candidates have declared assets **less than Rs.2 Lakh** (excluding a candidate with zero assets). The three candidates with lowest assets are as follows:

- **Candidate with Zero Assets:** 1 candidate namely **Kumar Rajiv** an **Independent** candidate from Patna Sahib constituency has declared zero assets.
- **Candidates with Liabilities:** A total of **20** candidates out of the 116 contesting candidates analyzed have declared liabilities above **Rs. 5 lakhs**. **Anil Kumar Sharma** of JD(U) from Jahanabad constituency has declared liabilities worth **Rs. 109.53 Crores** followed by **Shatrughan Sinha** of **BJP** from Patna Sahib constituency with liabilities worth **Rs. 16.87 crores** and **Dadan Yadav** of **BSP** from Buxar constituency with liabilities worth **Rs. 10.35 crores**.
- **Candidates with High Income:** **10** candidates have declared total annual Income of **over Rs.20 Lakhs**. **Anil Kumar Sharma** of JD(U) from Jahanabad constituency has declared the highest total income of **Rs. 10.76 crores** followed by **Lallan Rup Narayan Pathak** an Independent candidate from Buxar constituency with **Rs. 98.84 Lakhs** and **Shatrughan Sinha** of BJP from Patna Sahib constituency with **Rs. 91.21 Lakhs** of total income. \*Total income includes income of self, spouse and dependents
- **Candidates who have not declared Income Tax Details\*:** **58 (50%)** candidates out of the 116 contesting candidates analyzed have not declared income tax details. \*Some candidates may be exempted from filing Income Tax Returns
- **Candidates with High Assets who have not declared Income Tax Details:** 11 candidates with assets worth more than Rs. 50 Lakhs, have not declared Income Tax Details.

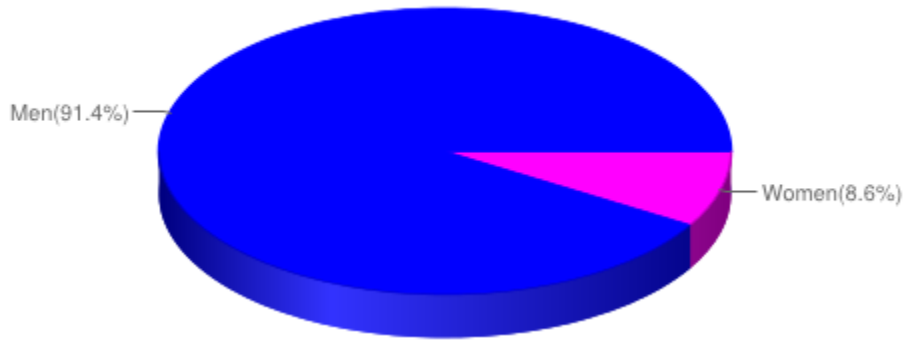
