

## Summary and Highlights

Jharkhand Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of all **208 candidates from 16 constituencies** who are contesting in the fifth phase of Jharkhand 2014 elections.



### Criminal Background

- Candidates with Criminal Cases:** Out of the **208** candidates, **59 (28%)** candidates have declared criminal cases against themselves.
- Candidates with Serious Criminal Cases:** **36 (17%)** candidates have declared serious criminal cases including cases related to **rape, murder, attempt to murder, kidnapping, crimes against women** etc.
- Candidates with cases related to murder:** 5 candidates have declared cases related to **murder**. **Devendra Dehri** of **CPI(M)** from **Litipara** constituency, **Krishna Mahto** of **JVM(P)** from **Rajmahal** constituency, **Surya Narayan Hansda** of **JVM(P)** from **Borio** constituency, **Pitar Hembram** of **Revolutionary Socialist Party** from **Dumka** constituency and **Arbind Ramdas**, Independent from **Godda** constituency have declared cases related to murder.
- Candidates with cases related to Attempt to Murder:** 11 candidates have declared cases of attempt to murder. Out of these 11 candidates, one candidate each is from **BJP, CPI(M), INC, JVM(P), LJP, Revolutionary Socialist Party, RJD, Samata Party** and 3 candidates are **independents**.
- Candidates with cases related to Crimes against Women:** 4 candidates have declared cases related to crimes against women. **Rajesh Kumar Sah** of **JMM** from **Godda** constituency has declared a case of **rape (IPC Section-376)** and **Assault or criminal force to woman with intent to outrage her modesty (IPC Section-354)**, **Abir Miyan** of **SP** from **Sarath** constituency and **Pitar Hembram** of **Revolutionary Socialist Party** from **Dumka** constituency have declared a case of **Assault or criminal force to woman with**

#### Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

intent to outrage her modesty (IPC Section-354). Paneshal Tudu, Independent from Jama constituency has declared an offence of Husband or relative of husband of a woman subjecting her to cruelty (IPC Section-498A).

- **Candidate with cases related to Kidnapping:** Birendra Mandal of BJP from Jamtara constituency and Surya Narayan Hansda of JVM(P) from Borio constituency have declared a case related to Kidnapping or abducting in order to murder (IPC Section-364). Krishna Mahto of JVM(P) from Rajmahal constituency has declared a case related to Kidnapping for ransom, etc. (IPC Section-364A).
- **Candidate with case related to Causing Communal Disharmony:** Birendra Mandal of BJP from Jamtara constituency has declared a case related to Deliberate and malicious acts, intended to outrage religious feelings or any class by insulting its religion or religious beliefs (IPC Section-295A)
- **Candidate with related to robbery and dacoity:** Surya Narayan Hansda of JVM(P) from Borio constituency has declared a case of dacoity (IPC Section-395) and Robbery, or dacoity, with attempt to cause death or grievous hurt (IPC Section-397).
- **Party wise Candidates with Criminal Cases:** 7 (47%) out of 15 candidates from BJP, 11 (69%) out of 16 candidates from JMM, 8 (53%) out of 15 candidates fielded by JVM(P), 4 (36%) out of 11 candidates from INC and 9 (14%) out of 65 Independent candidates have declared criminal cases against themselves in their affidavits.
- **Party wise Candidates with Serious Criminal Cases:** 3 (20%) out of 15 candidates from BJP, 8 (50%) out of 16 candidates from JMM, 4 (27%) out of 15 candidates fielded by JVM(P), 2 (18%) out of 11 candidates from INC and 7 (11%) out of 65 Independent candidates have declared serious criminal cases against themselves in their affidavits.
- **Red Alert Constituencies\*:** 11 constituencies have at least 3 candidates with declared criminal cases. Mahagama Constituency has declared the most number of candidates with criminal cases with 7 candidates with declared criminal cases followed by Jamtara and Godda constituency with 6 candidates with criminal cases.

\*Red Alert Constituencies are those which have 3 or more candidates with criminal cases contesting elections.

### Financial Background

- **Cronepati Candidates:** Out of the 208 candidates, 37 (18%) are crorepati.
- **Party-wise Cronepati Candidates:** 12 (75%) out of 16 candidates from JMM, 7 (47%) out of 15 candidates from BJP, 5 (33%) out of 15 candidates from JVM(P), 3 (27%) out of 11 candidates from INC and 4 (6%) out of 65 Independent candidates have declared assets worth more than Rs. 1 crore.
- **Average Assets:** The average assets per candidate contesting in the fifth phase of Jharkhand elections is Rs.74.63 lakhs.

- Party-wise Average Assets:** Among major parties, the average assets per candidate for **16 JMM** candidates is **Rs 2.99 crores**, **15 BJP** candidates have average assets of **Rs.2.24 crores**, **15 JVM (P)** candidates have average assets worth **Rs. 1.57 crores**, **11 INC** candidates have average assets worth of **Rs. 97.42 lakhs** and **65 Independent** candidates have average assets of **Rs. 22.07 lakhs**.

**Undeclared PAN:** 82 (39%) candidates have not declared their PAN details.

### Other Background Details

- **Education Details of Candidates:** 132 (63%) candidates have declared that they have an education qualification of **12<sup>th</sup> pass or below** while **73 (35%)** candidates have declared having an educational qualification of **graduate or above**.
- **Age Details of Candidates:** 151 (73%) candidates have declared their age to be between **25 to 50 years** while **49 (24%)** candidates have declared their age to be between **51 to 70 years**. 2 candidates are aged between **71 and 80 years**. 5 candidates have not given their age details.
- **Gender Details of Candidates:** 15 (7%) female candidates are contesting in the **Jharkhand 2014 Phase-5 elections**.
- **Profession Details of Candidates:** 93 candidates have declared **agriculture** as their main profession, for 23 candidates it is **business**, for 12 candidates it is **politics** and for 40 candidates it is **social work**. 9 candidates have declared that they have **retired**.




