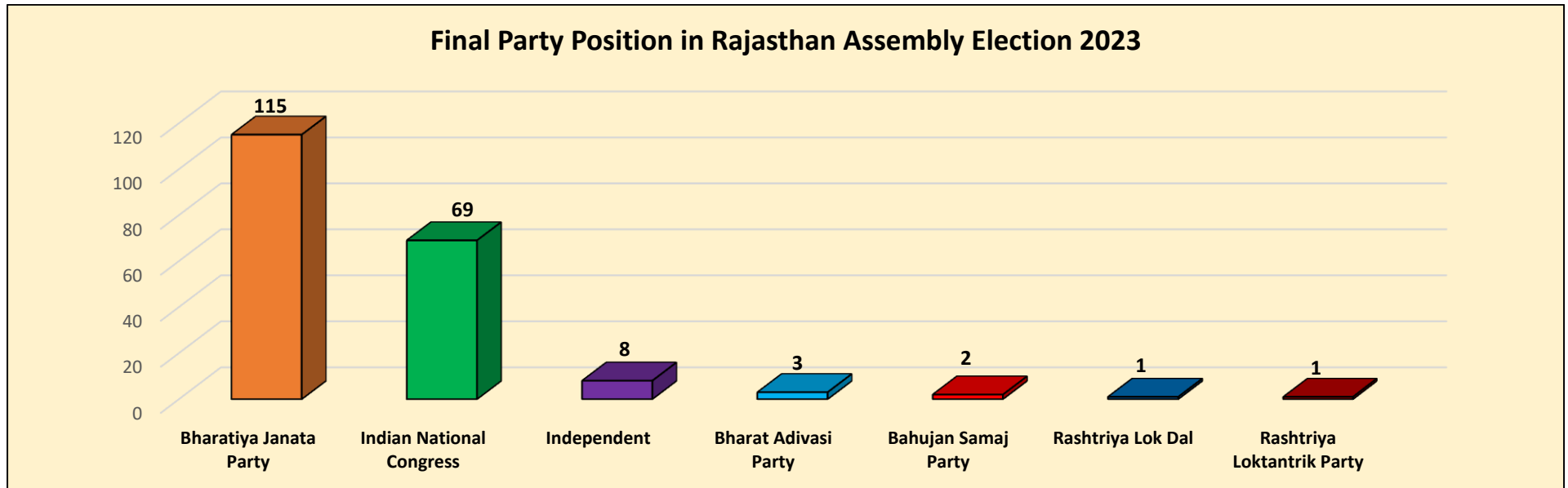

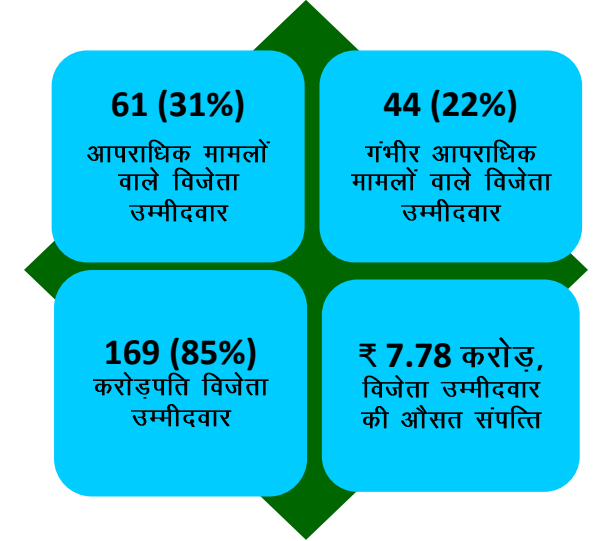

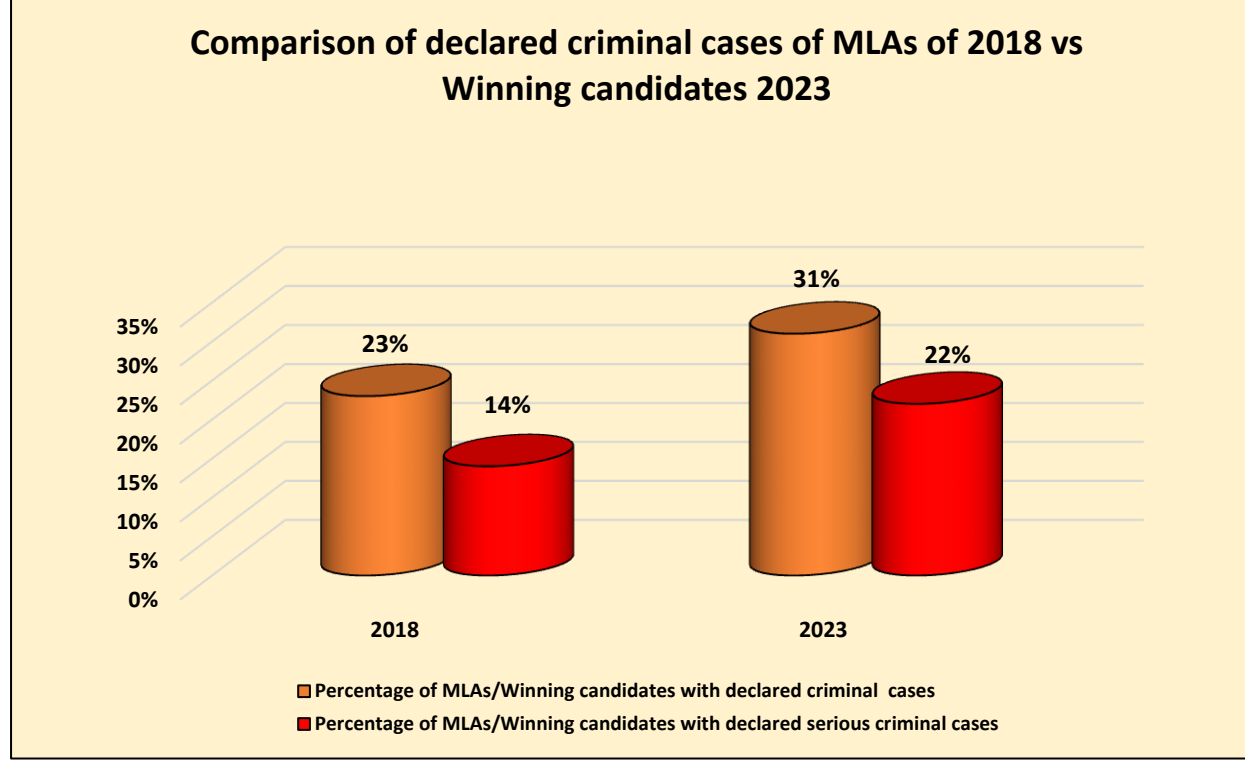

आपराधिक पृष्ठभूमि

- विजेता उम्मीदवारों द्वारा घोषित आपराधिक मामले:— 199 में से 61 (31 प्रतिशत) विजेता उम्मीदवारों ने अपने ऊपर आपराधिक मामले घोषित किये हैं। राजस्थान विधानसभा चुनाव 2018 में 199 में से 46 (23 प्रतिशत) विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये थे।
- विजेता उम्मीदवारों द्वारा घोषित गंभीर आपराधिक मामले:— 44 (22 प्रतिशत) विजेता उम्मीदवारों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं। राजस्थान विधानसभा चुनाव 2018 में 199 में से 28 (14 प्रतिशत) विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये थे।





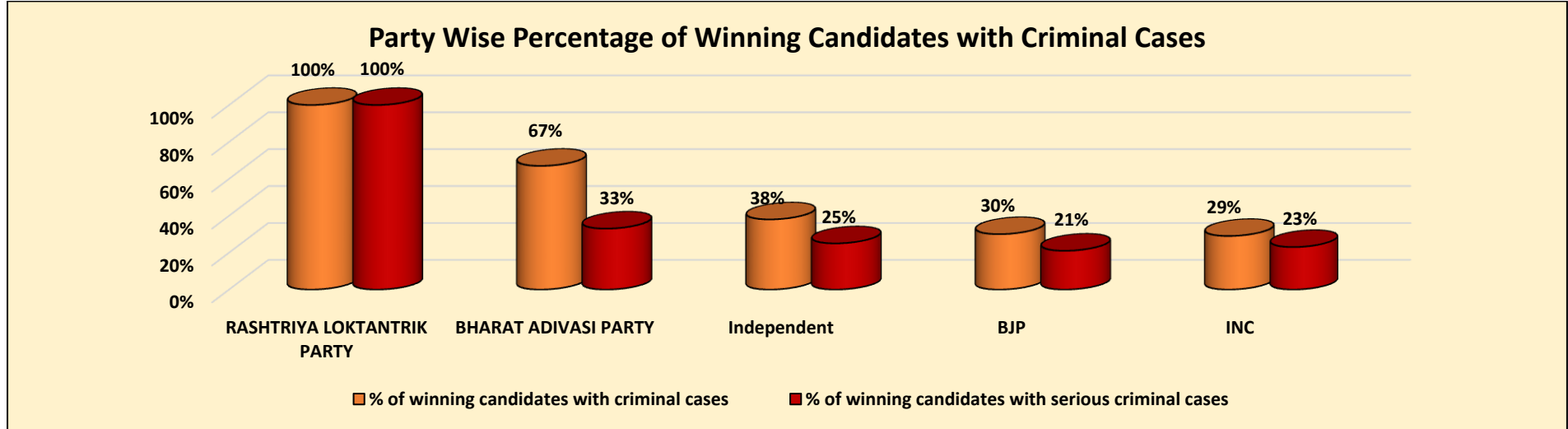

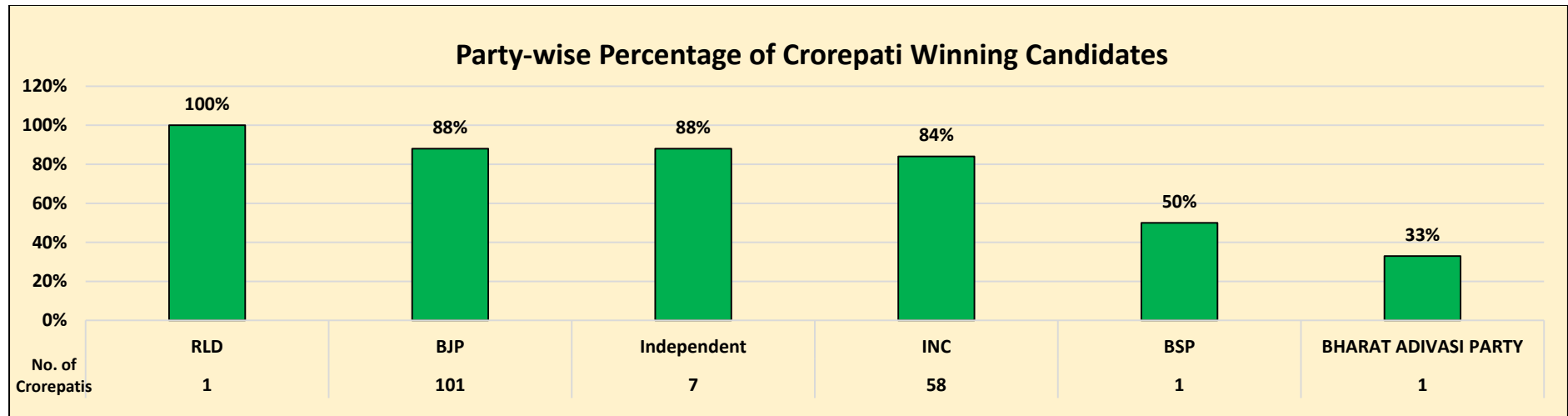

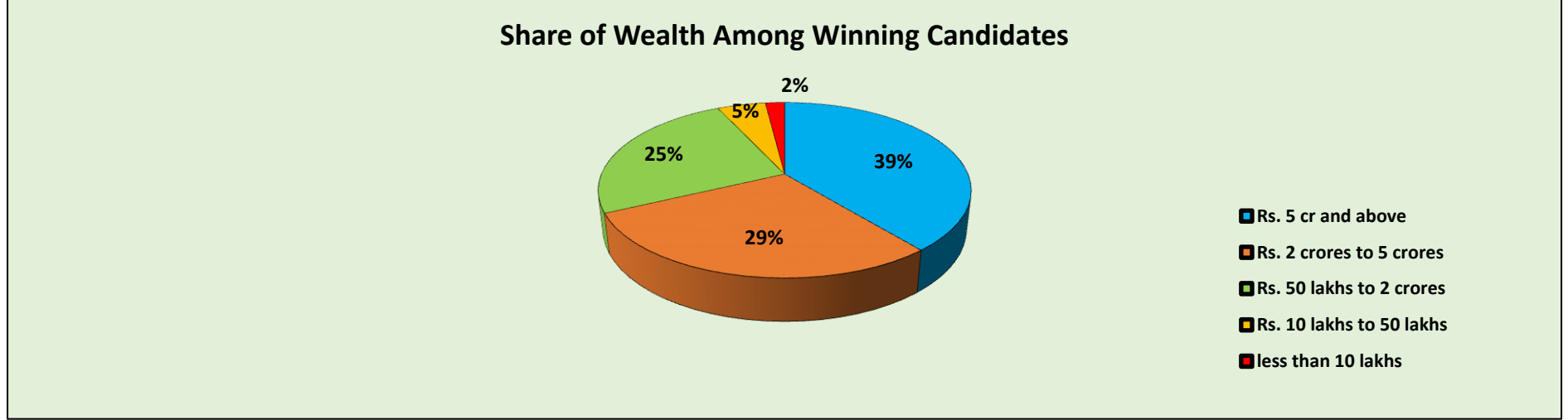

आलेख-करोड़पति विजेता उम्मीदवारों का प्रतिशत-दलवार



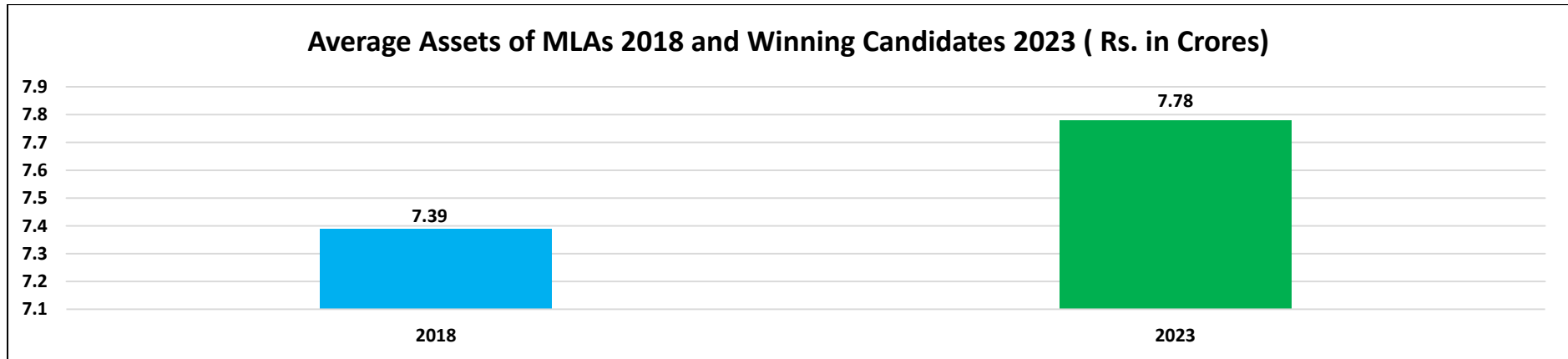

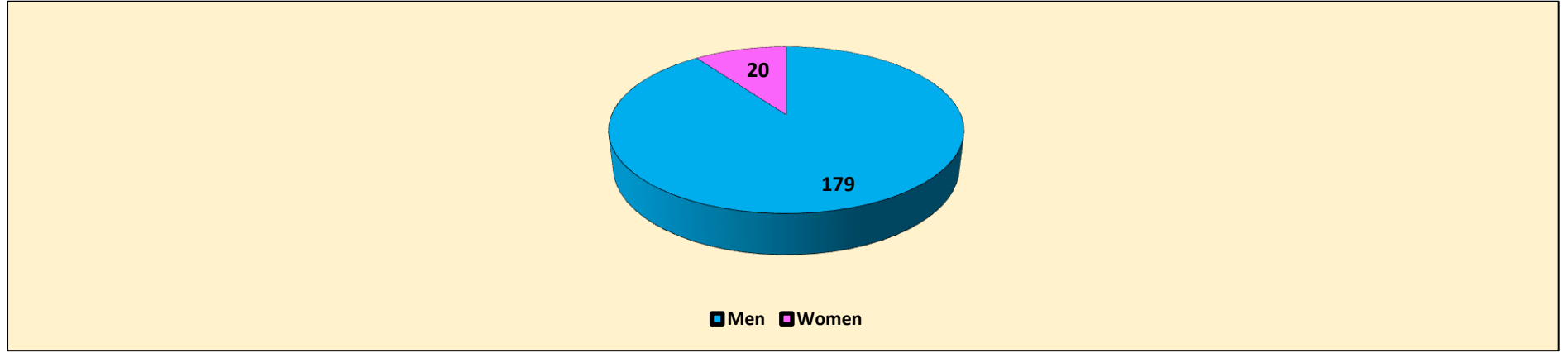

एडीआर, भारत के चुनाव आयोग के साथ जमा किए गए शपथपत्रों से चुनाव के समय उम्मीदवारों द्वारा प्रस्तुत की गई पृष्ठभूमि की जानकारी के विश्लेषण और प्रसार में अत्याधिक सावधानी बरतता है। इस तरह की जानकारी का उद्देश्य केवल राजनीति में बढ़ती आपराधिकता, चुनावों में धन के दुरुपयोग में वृद्धि को उजागर करना है ताकि पारदर्शिता, जवाबदेही और सुशासन की व्यवस्था को सुगम बनाया जा सके और मतदाताओं को एक सूचित विकल्प बनाने में सक्षम बनाया जा सके। इसलिए, यह अपेक्षा की जाती है कि इस रिपोर्ट का उपयोग करने वाला कोई भी व्यक्ति एडीआर द्वारा उपलब्ध कराए गए डेटा का उपयोग करते समय अत्यधिक सावधानी बरतेगा। एडीआर डेटा में किसी भी तरह के गलत इस्तेमाल, परिवर्तन, समझने में असमर्थता, गलत व्याख्या या हेरफेर के लिए जिम्मेदार नहीं है जिससे किसी विशेष राजनीतिक दल या राजनेता या उम्मीदवार को निशाना बनाया जा सके।
