मंत्रिमंडल के पुनर्गठन के बाद, राजस्थान इलेक्शन वॉच और एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स ने राजस्थान राज्य विधानसभा 2018 से मुख्यमंत्री सहित सभी 30 मंत्रियों के शपथपत्रों का विश्लेषण किया।

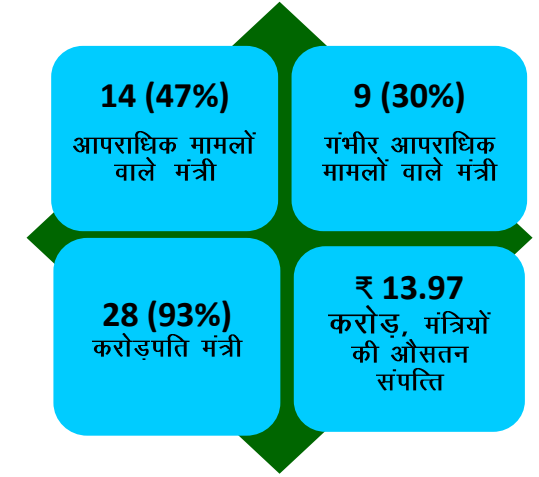
