## रिपोर्ट के मुख्य अंश

एसोसिएशन फॉर डेमोक्रेटिक रिफॉर्म्स और राजस्थान इलेक्शन वॉच ने राजस्थान विधानसभा के 200 में से 199 वर्तमान विधायकों के वित्तीय, आपराधिक एवं अन्य विवरणों का विश्लेषण किया। वर्तमान में उदयपुर विधानसभा क्षेत्र में सीट रिक्त हैं।

यह विश्लेषण 2018 के विधानसभा चुनावों और उसके बाद हुए उपचुनावों में उम्मीदवारों द्वारा प्रस्तुत शपथपत्रों पर आधारित है।

### वर्तमान विधायक जिन्होंने राजनीतिक दल बदल लिया (13 अक्टूबर 2023 तक)

2018 के विधानसभा चुनाव के बाद 7 वर्तमान विधायकों ने अपनी पार्टी बदल ली थी। उसका विवरण नीचे दिया गया है।

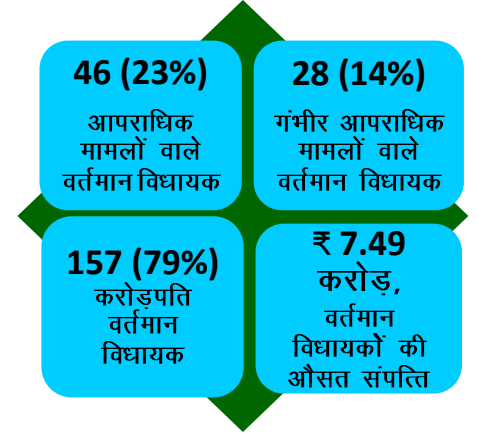

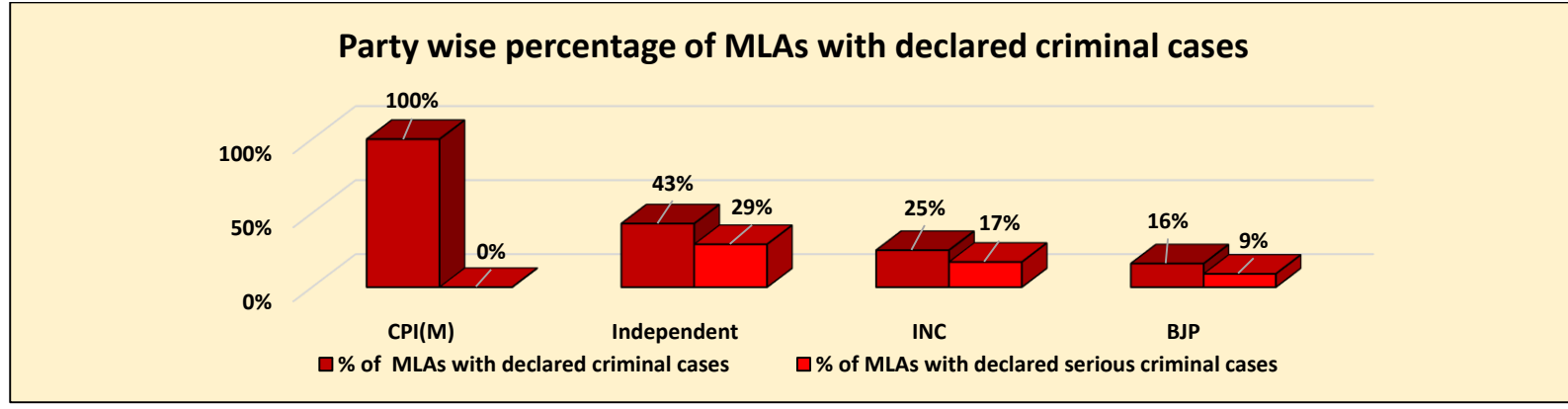
## आपराधिक पृष्ठभूमि

- ☞ विधायकों द्वारा घोषित आपराधिक मामले:- 199 में से 46 (23 प्रतिशत) वर्तमान विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं।
- ☞ विधायकों द्वारा घोषित गंभीर आपराधिक मामले:- 28 (14 प्रतिशत) वर्तमान विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं।
- ☞ हत्या से सम्बन्धित मामले घोषित करने वाले विधायक: 1 वर्तमान विधायक ने अपने ऊपर हत्या (आईपीसी-302) से सम्बन्धित मामला घोषित किया है।
- ☞ हत्या का प्रयास से सम्बन्धित मामले घोषित करने वाले विधायक: 4 वर्तमान विधायकों ने अपने ऊपर हत्या का प्रयास (आईपीसी-307) से सम्बन्धित मामले घोषित किये हैं।
- ☞ वर्तमान विधायकों द्वारा घोषित आपराधिक मामले-दलवार: INC के 108 में से 27 (25 प्रतिशत), BJP के 69 में से 11 (16 प्रतिशत), CPI(M) के 2 (100 प्रतिशत), और 14 में से 6 (43 प्रतिशत) निर्दलीय विधायकों ने अपने ऊपर आपराधिक मामले घोषित किये हैं।
- ☞ वर्तमान विधायकों द्वारा घोषित गंभीर आपराधिक मामले-दलवार: INC के 108 में से 18 (17 प्रतिशत), BJP के 69 में से 6 (9 प्रतिशत) और 14 में से 4 (29 प्रतिशत) निर्दलीय विधायकों ने अपने ऊपर गंभीर आपराधिक मामले घोषित किये हैं।

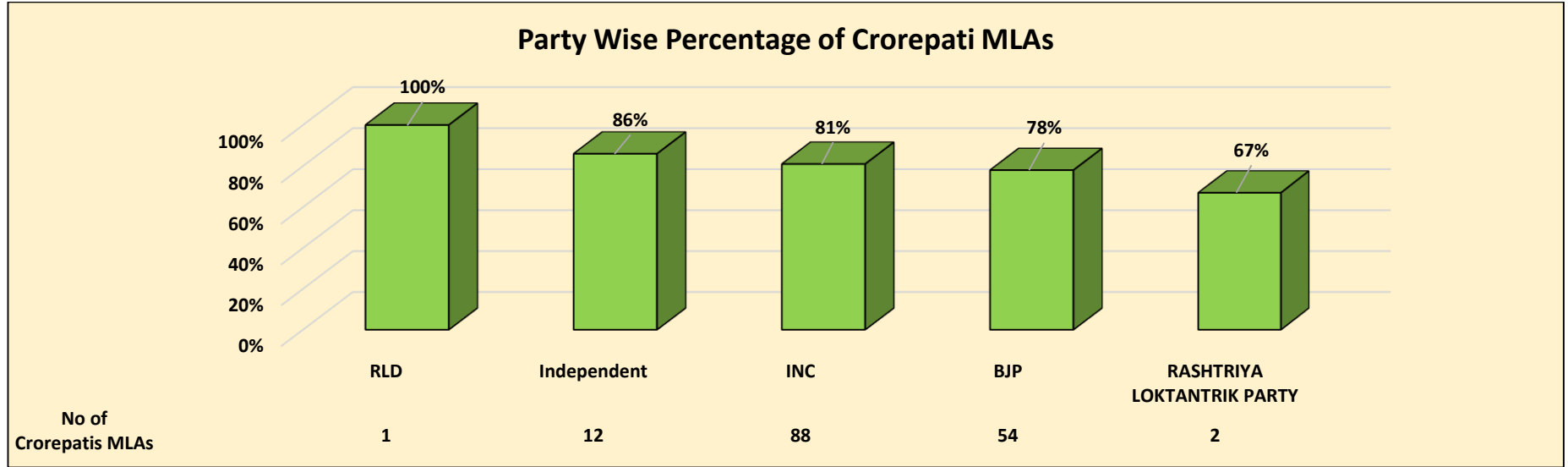

5. हमला, हत्या, अपहरण, बलात्कार से सम्बन्धित अपराध
6. लोक प्रतिनिधित्व अधिनियम में उल्लेखित अपराध (धारा 8)
7. भ्रष्टाचार निरोधक अधिनियम कानून के तहत अपराध
8. महिलाओं के ऊपर अत्याचार से सम्बन्धित अपराध

### वित्तीय पृष्ठभूमि

- ☞ अरबपति विधायक: 199 में से 3 (2 प्रतिशत) वर्तमान विधायक अरबपति हैं।
- ☞ करोड़पति विधायक: 199 में से 157 (79 प्रतिशत) वर्तमान विधायक करोड़पति हैं।
- ☞ करोड़पति विधायक-दलवार: **INC** के 108 में से 88 (81 प्रतिशत), **BJP** के 69 में से 54 (78 प्रतिशत), **Rashtriya Loktantrik Party** के 3 में से 2 (67 प्रतिशत), **RLD** के 1 (100 प्रतिशत) और **निर्दलीय** 14 में से 12 (86 प्रतिशत) विधायक करोड़पति हैं। (घोषित संपत्ति ₹ 1 करोड़ से ज़्यादा)।

- ☞ **शैक्षिक योग्यता:** 59 (30 प्रतिशत) विधायकों ने अपनी शैक्षिक योग्यता 5वीं और 12वीं के बीच घोषित की है, जबकि 128 (64 प्रतिशत) विधायकों ने अपनी शैक्षिक योग्यता स्नातक और इससे ज्यादा घोषित की है। 5 विधायकों ने अपनी शैक्षिक योग्यता डिप्लोमा धारक घोषित की है। 7 विधायकों ने अपनी शैक्षिक योग्यता साक्षर घोषित की हैं।
- ☞ **विधायकों की आयु:** 80 (40 प्रतिशत) विधायकों ने अपनी आयु 25 से 50 वर्ष के बीच घोषित की है, जबकि 119 (60 प्रतिशत) विधायकों ने अपनी आयु 51 से 85 वर्ष के बीच घोषित की है।
- ☞ **महिला प्रतिनिधित्व:** 199 में से 27 (14 प्रतिशत) महिला विधायक हैं।

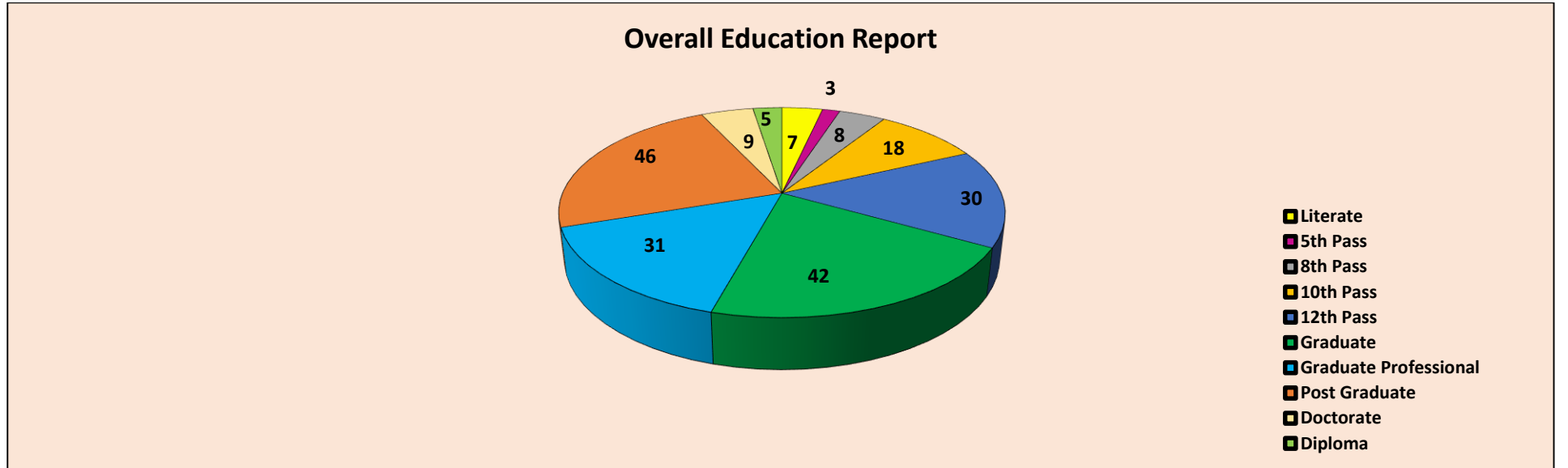

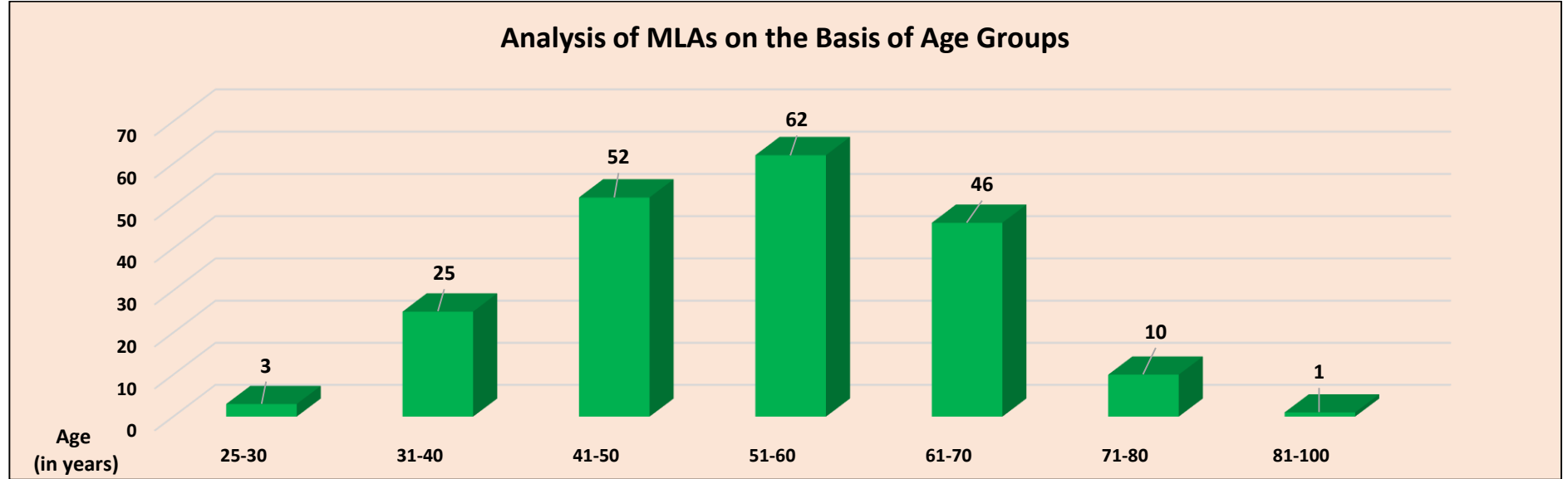

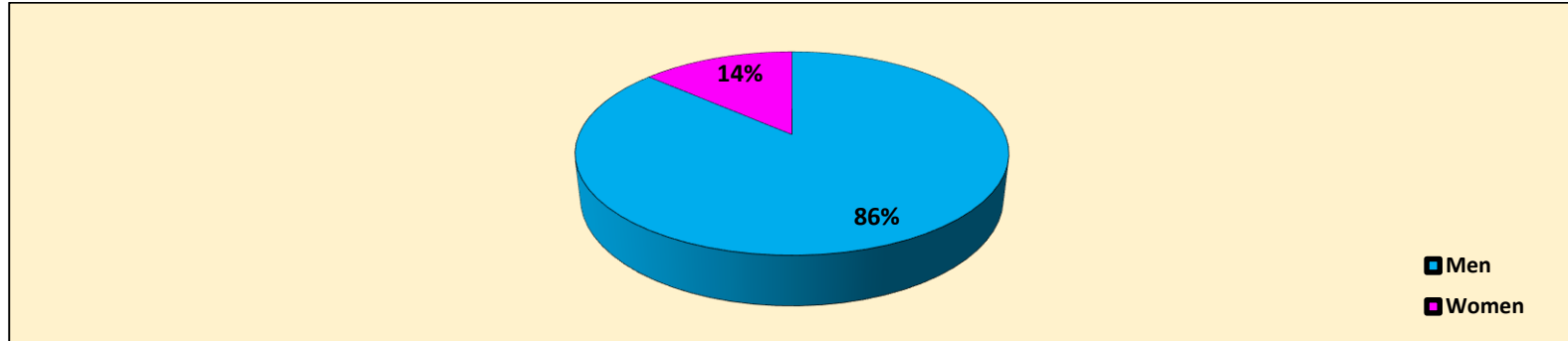
