Please refer to your application dated 24/12/2012 on the above cited subject which is received in this office on 14/01/2013 from the O/o Income Tax Officer, Ward 1(4), Tarn Taran.

1. In this connection, it is being conveyed to you that information sought by you is not being provided in view of section 8(1)(j) of RTI act, 2005 which read as under –

“...8(1)(j) information which relates to personal information the disclosure of which has no relationship to any public activity or interest, or which would cause unwarranted invasion of the privacy of the individual unless the CPIO or the appellate authority, as the case may be, is satisfied that the larger public interest justifies the disclosure of such information...”

These exemption clauses are invoked as no larger public interest will be served by the disclosure of the above information u/s 8(1) (d). Further the information sought is third party information, the disclosure of which can cause unwarranted invasion of the privacy of the individual u/s 8(1) (j) of RTI Act, 2005. The applicant has not indicated how larger public interest is served by such disclosure.
