

उत्तर प्रदेश 2012 में होने वाले विधान सभा चुनाव के लिए उम्मीदवारों की घोषित की गई सूची का विश्लेषण (कांग्रेस, भाजपा, सपा, रालोद)

नेशनल इलेक्शन वॉच (एनईडब्लू) भारत में चुनाव सुधारों, लोकतंत्र के उन्नयन और सुशासन के लिए कार्यरत 1200 से अधिक गैर-सरकारी और अन्य नागरिक संगठनों का राष्ट्रव्यापी अभियान है जो उत्तरप्रदेश विधानसभा चुनाव 2012 के लिए राजनीतिक पार्टियों द्वारा घोषित उम्मीदवारों की निगरानी कर रहा है। एसोसिएशन फॉर डिमोक्रेटिक रिफार्म्स (एडीआर), उत्तरप्रदेश इलेक्शन वॉच (यूपीईडब्लू), और एनईडब्लू ने विभिन्न राजनीतिक पार्टियों द्वारा घोषित उम्मीदवारों की निम्नलिखित सूची को देखा और इन उम्मीदवारों के रिकार्डों की छानबीन उस 75 हजार से अधिक दस्तावेजों के आधार पर किया जिसे एडीआर और एनईडब्लू 2003 से ही एकत्र करते रहे हैं। आगामी उत्तरप्रदेश विधानसभा चुनावों के लिए विभिन्न राजनीतिक पार्टियों ने अपने उम्मीदवारों की पहली सूची जारी कर दिया है। उत्तरप्रदेश इलेक्शन वॉच और एनईडब्लू ने आगामी चुनावों में दोबारा चुनाव लड़ने वाले उम्मीदवारों की वित्तीय और आपराधिक पृष्ठभूमि के संक्षिप्त विश्लेषण किया। यह विश्लेषण आगामी चुनावों में दोबारा चुनाव लड़ने वाले उम्मीदवारों की पृष्ठभूमि का विवरण देता है।

उत्तरप्रदेश विधानसभा चुनाव 2012 के लिए भारतीय जनता पार्टी, कांग्रेस, समाजवादी पार्टी और राष्ट्रीय लोकदल के उम्मीदवारों की पहली सूची में क्रम 26, 26,24 और 1 उम्मीदवार की आपराधिक पृष्ठभूमि है। (वर्ष 2007 चुनाव और बाद के शपथपत्रों के आधार पर)

पार्टियों द्वारा अभी तक जारी उम्मीदवारों की सूची में उत्तरप्रदेश इलेक्शन वॉच और नेशनल इलेक्शन वॉच को आपराधिक पृष्ठभूमि के कुल 77 उम्मीदवार मिले हैं।

- भाजपा ने उत्तरप्रदेश 2012 चुनावों के लिए 220 उम्मीदवारों की घोषणा की है।
- कांग्रेस ने उत्तरप्रदेश 2012 चुनावों के लिए 215 उम्मीदवारों की घोषणा की है।
- सपा ने उत्तरप्रदेश 2012 चुनावों के लिए 165 उम्मीदवारों की घोषणा की है।
- रालोद ने उत्तरप्रदेश 2012 चुनावों के लिए 17 उम्मीदवारों की घोषणा की है।

उत्तरप्रदेश 2012 चुनावों के लिए भाजपा, कांग्रेस, सपा और रालोद ने अभी तक 617 उम्मीदवारों की घोषणा की है। एनईडब्लू को 248 उम्मीदवारों के शपथपत्र मिले हैं जिसे उम्मीदवारों ने पिछले चुनावों (2007 विधानसभा चुनाव या 2009 लोकसभा चुनाव) के दौरान चुनाव आयोग को समर्पित किया था।

38 उम्मीदवारों के खिलाफ गंभीर अपराधों जैसे-हत्या, हत्या की कोशिश, डकैती, चोरी, अपहरण इत्यादि के मामले लंबित हैं जैसाकि उन्होंने पहले के शपथपत्रों में घोषित किया है। गंभीर आरोपों वाले उम्मीदवारों की सूची में भाजपा के 13, कांग्रेस के 13 और सपा के 12 उम्मीदवार हैं।

भाजपा ने अभी तक आगामी उत्तरप्रदेश विधानसभा चुनावों के लिए 220 उम्मीदवारों की घोषणा की है। इनमें से 91 के रिकार्ड एनईडब्लू को मिल पाए हैं और उनमें 26 की आपराधिक पृष्ठभूमि है। उन सभी उम्मीदवारों की सूची अंत में संलग्न किया गया है।

उत्तरप्रदेश 2012 विधानसभा चुनावों के लिए कांग्रेस द्वारा घोषित 215 उम्मीदवारों में से 75 के शपथपत्र एनईडब्लू को मिले हैं जिनमें से 26 उम्मीदवारों की आपराधिक पृष्ठभूमि है और 13 उम्मीदवारों के खिलाफ गंभीर आपराधिक मामले लंबित हैं। यह सूची भी अंत में संलग्न है।

सपा के घोषित 165 उम्मीदवारों में एनईडब्लू को 77 उम्मीदवारों द्वारा पिछले चुनावों में समर्पित शपथपत्र मिल सके हैं और उनमें 24 की आपराधिक पृष्ठभूमि है। उम्मीदवारों की आपराधिक पृष्ठभूमि के आधार पर विशलेषण का उल्लेख इस रिपोर्ट में अन्यत्र किया गया है।

रालोद के उत्तरप्रदेश विधानसभा चुनाव 2012 के लिए घोषित 17 उम्मीदवारों में से केवल पांच के शपथपत्रों का विशलेषण एनईडब्लू कर पाया है। उनमें से केवल एक उम्मीदवार की आपराधिक पृष्ठभूमि है।

विभिन्न पार्टियों के जिन उम्मीदवारों के शपथपत्रों का विशलेषण एडीआर और एनईडब्लू ने किया है, उनके आपराधिक और वित्तीय पृष्ठभूमि का विवरण निम्नलिखित तालिका में दिया गया है।

पार्टियों द्वारा घोषित उम्मीदवारों के बारे में जानकारी एकत्र की गई और केवल उनके नामों का मिलान एनईडब्लू के मौजूदा डाटाबेस से किया गया जो उम्मीदवारों द्वारा पहले के चुनाव में दाखिल शपथपत्रों पर आधारित है।

नेशनल इलेक्शन वॉच (एनईडब्लू) एक राष्ट्रव्यापी अभियान है जिसमें 1200 से अधिक गैर-सरकारी संगठन और नागरिक संगठन मिलकर भारत में चुनाव सुधार, लोकतंत्र की उन्नति और सुशासन के लिए काम करते हैं। नेशनल इलेक्शन वॉच भारत के लगभग सभी राज्यों में सक्रिय है और एडीआर व दो अन्य संगठनों की जनहित याचिका पर चुनाव में हिस्सेदार सभी उम्मीदवारों द्वारा अपनी शैक्षिक, वित्तीय व आपराधिक पृष्ठभूमि की घोषणा को अनिवार्य करने के सुप्रीम कोर्ट के फैसले के बाद सभी राज्यों तथा लोकसभा चुनावों की निगरानी किया है।

एडीआर के बारे में

एसोसिएशन फॉर डिमोक्रेटिक रिफार्म्स एक अराजनैतिक, निष्पक्ष और एक गैर-सरकारी संगठन है जिसकी ओर से दिसंबर 1999 में दायर जनहित याचिका के परिणामस्वरूप सुप्रीम कोर्ट का 13 मार्च 2003 का आदेश आया जिससे चुनाव लड़ने वाले सभी उम्मीदवारों को अपनी आपराधिक, वित्तीय और शैक्षिक पृष्ठभूमि की घोषणा करना अनिवार्य हो गया। तभी से एडीआर ने लगभग सभी राज्य विधानसभाओं और लोकसभा चुनावों की निगरानी किया है। चुनावी और राजनीतिक प्रक्रियाओं को स्वच्छ और पारदर्शी बनाने पर ध्यान केंद्रीत करते हुए वह भारत में लोकतंत्र को मजबूत बनाने और सुशासन स्थापित करने की दिशा में निरंतर सक्रिय है। अभी वह उन सभी राज्यों में चुनावी निगरानी कर रहा है जिनमें विधानसभा चुनाव होने वाले हैं।
