Order U/s - 19 of the RTI Act, 2005

The present appeal u/s 19 of the RTI Act, 2005 lies against the order of CPIO-cum- DCIT, Circle-31(1) dated 12.04.2010. The CPIO has rejected the application of the appellant seeking information in respect of Sh. Sachin Pilot, 3, Safderjung Road, New Delhi. The CPIO has held that the information sought by the applicant is covered u/s 8 (1)(d) of the RTI Act, 2005.

2. I have carefully examined the appeal filed by the appellant which has been received in this office on 11.05.2010. A letter was issued to the appellant on 12.05.10 fixing the case for hearing on 20.05.2010 at 11.30 A.M. No one has attended on 20.05.2010. Subsequently, the case has been re-fixed for hearing on 31.05.2010. On 31.05.2010 also, no one has attended the hearing.

3. After examining the order of the CPIO and submission of the appellant, I uphold the order of the CPIO. Accordingly, the appeal of the appellant is disposed off on the basis of material on record.
