Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of 659 candidates out of 805 who are contesting for the Thane Municipal Corporation (TMC) Elections, scheduled to be held on 21st February, 2017. There are total 131 seats spread across 33 wards (32 wards will elect 4 members each and 1 ward will elect 3 members). The rest of the affidavits were not analysed as they were not available or uploaded on the website at the time of making this report.

Criminal Background

- **Candidates with Criminal Cases:** 107 (16%) out of 659 analyzed candidates have declared criminal cases against themselves.

- **Candidates with Serious Criminal Cases:** 84 (13%) out of 659 analyzed candidates have declared serious criminal cases against themselves like murder, attempt to murder, criminal intimidation, kidnapping, habitual dealing in slave, extortion, Cheating and forgery, etc.

- **Party wise Candidates with declared Criminal Cases:**

20 (21%) out of 96 candidates analysed from Shivsena, 14 (15%) out of 92 candidate analysed from BJP, 20 (23%) out of 86 candidate analysed from MNS, 23 (32%) out of 71 candidate analysed from NCP, 4 (9%) out of 43 candidates analysed from INC and 3 (17%) out of 18 candidates analysed from All India Majlis E Ittehadul Muslimeen (AIMEM) have declared criminal cases against themselves in their affidavits.

- **Party wise Candidates with declared Serious Criminal Cases:** 13 (14%) out of 96 candidates analysed from Shivsena, 12 (13%) out of 92 candidate analysed from BJP, 17 (20%) out of 86 candidate analysed from MNS, 12 (17%) out of 71 candidate analysed from NCP, 4 (9%) out of 43 candidates analysed from INC and 3 (17%) out of 18 candidates analysed from All India Majlis E Ittehadul Muslimeen (AIMEM) have declared serious criminal cases against themselves in their affidavits.

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

- **Party wise Crorepati Candidates:** **57 (59%)** out of **96** candidates analysed from **Shivsena**, **47 (51%)** out of **92** candidate analysed from **BJP**, **36 (51%)** out of **71** candidate analysed from **NCP**, **20 (47%)** out of **43** candidate analysed from **INC** and **13 (15%)** out of **86** candidates analysed from **MNS** are Crorepatis.

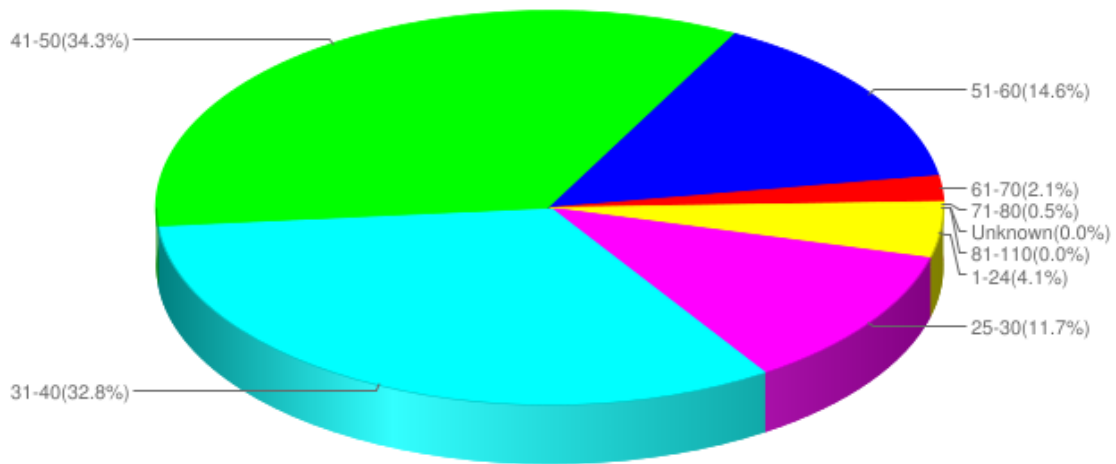

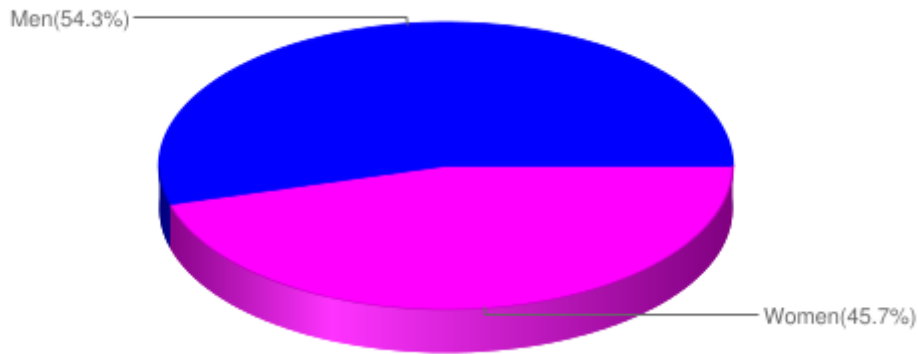
