Summary and Highlights

The Uttar Pradesh Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **83** out of **85** candidates, who are contesting in the following constituencies in the Uttar Pradesh Phase II Lok Sabha Elections.

1. Agra
2. Aligarh
3. Amroha
4. Bulandshahr
5. Fatehpur Sikri
6. Hathras
7. Mathura
8. Nagina

There are 2 candidates who have not been analysed due to unavailability of their properly scanned and complete affidavits, at the time of making this report. The details of these 2 candidates are given below:

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

Criminal Background

- **Candidates with Criminal Cases:** Out of 83 candidates analyzed, **19(23%)** candidates have declared criminal cases against themselves.
- **Candidates with Serious Criminal Cases:** **14(17%)** candidates have declared serious criminal cases against themselves.
