## Summary and Highlights

The **Uttar Pradesh Election Watch** and **Association for Democratic Reforms (ADR)** have analysed the self-sworn affidavits of **79** out of **80** winners in the Lok Sabha elections 2019 for Uttar Pradesh.

A **BJP MP** namely **Devendra Singh** from Akbarpur constituency has not been analysed due to the unavailability of his complete and properly scanned affidavit on the ECI website while making the report.

### Criminal Background

- **Winners with Criminal Cases:** Out of **79** winners analyzed, **44 (56%)** winners have declared criminal cases against themselves. Out of **80** winners analysed during **Lok Sabha 2014 elections**, **28 (35%)** winners had declared criminal cases against themselves
- **Winners with Serious Criminal Cases:** **37(47%)** winners have declared serious criminal cases including cases related to **murder, attempt to murder, communal disharmony, crimes against women** etc. Out of **80** winners analysed during **Lok Sabha 2014 elections**, **22 (28%)** winners had declared serious criminal cases against themselves.

#### *Criteria for serious criminal cases*

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.
