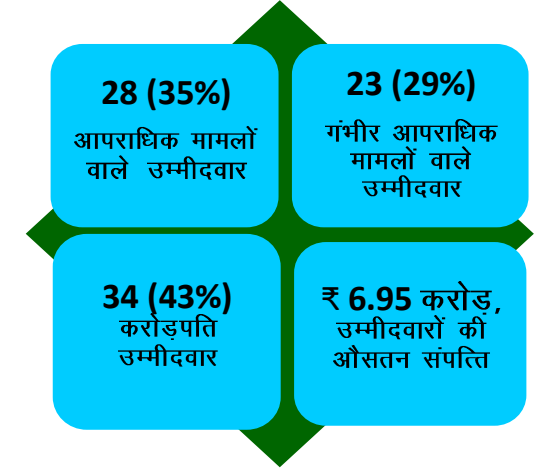

5. हमला, हत्या, अपहरण, बलात्कार से सम्बन्धित अपराध
6. लोक प्रतिनिधित्व अधिनियम में उल्लेखित अपराध (धारा 8)
7. भ्रष्टाचार निरोधक अधिनियम कानून के तहत अपराध
8. महिलाओं के ऊपर अत्याचार से सम्बन्धित अपराध

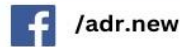
