Summary and Highlights

The Uttar Pradesh Election Watch and Association for Democratic Reforms (ADR) have analysed the self-sworn affidavits of **all 172 out of 177** candidates, who are contesting in the following constituencies in the Uttar Pradesh Phase 6 Lok Sabha Elections.

1. Sultanpur
2. Azamgarh
3. Machhlishahr
4. Pratapgarh
5. Phulpur
6. Sant Kabir Nagar
7. Bhadohi
8. Shrawasti
9. Domariyaganj
10. Lalganj
11. Basti
12. Allahabad
13. Ambedkar Nagar

Criteria for serious criminal cases

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

5 candidates have not been analysed as their complete and properly scanned affidavits were not available on the ECI website at the time of making this reports. The details of these candidates are given below:
