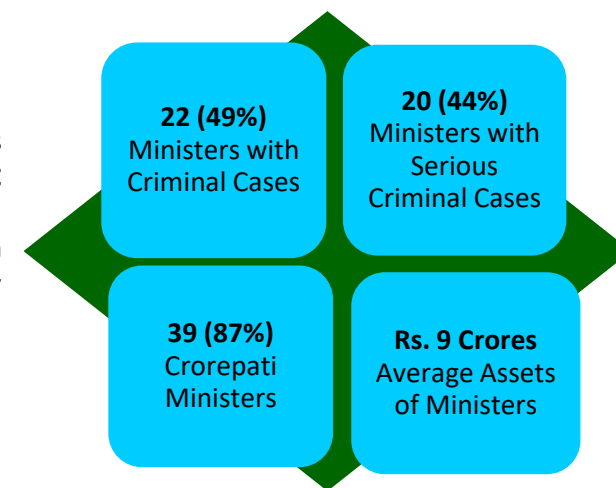

Summary and Highlights

Uttar Pradesh Election Watch and Association for Democratic Reforms have analysed the self-sworn affidavits of **45 Ministers out of 53** Ministers including Chief Minister from Uttar Pradesh State Assembly 2022. **2 MLC** minister namely **Sanjay Nishad** and **Jitin prasada** were not analysed due to the unavailability of their affidavits on the CEO website at the time of making this report and the details of **JPS Rathore, Narendra Kashyap, Dinesh Pratap Singh, Dayashankar Mishra Dayalu, Jaswant Saini** and **Danish Azad Ansari** were not analysed as they are not currently members of either any house, state assembly or legislative council.

The information is based on the affidavits submitted by the candidates prior to 2022 Uttar Pradesh Assembly Elections and MLC elections.

Criminal Background

- **Ministers with Criminal Cases:** 22(49%) ministers have declared criminal cases against themselves.
- **Ministers with Serious Criminal Cases:** 20(44%) ministers have declared serious criminal cases against themselves.

Financial Background

- **Crorepati Ministers:** Out of the 45 ministers analysed, 39 (87%) are crorepatis.
- **Average Assets:** The average assets of 45 ministers analysed is Rs 9 crores.
- **Minister with Highest Assets:** The minister with the highest declared total assets is **Mayankeshwar Sharan Singh** from **Tiloi** constituency with assets worth **Rs. 58.07 crores**.
- **Minister with Lowest Assets:** The minister with the lowest declared total assets is **Dharamveer Singh** an **MLC Member** from **Uttar Pradesh Legislative Council** with assets worth **Rs. 42.91 lakhs**.
- **Liabilities:** A total of 27 ministers have declared liabilities out of which the minister with the highest liabilities is **Rakesh Sachan** of **Bhognipur** constituency with **Rs. 8.17 crores** of liabilities.

- Criteria for serious criminal cases**
1. Offence for which maximum punishment is of 5 years or more.
 2. If an offence is non-bailable
 3. If it is an electoral offence (for eg. IPC 171E or bribery)
 4. Offence related to loss to exchequer
 5. Offences that are assault, murder, kidnap, rape related
 6. Offences that are mentioned in Representation of the People Act (Section 8)
 7. Offences under Prevention of Corruption Act
 8. Crimes against women.

Other Background details (Education, Gender, Age)

- **Ministers' Education:** 9(20%) ministers have declared their educational qualification to be between 8th and 12th standard while 36(80%) ministers have declared having an educational qualification of **graduate or above**.
- **Ministers' Age:** 20(44%) ministers have declared their age to be between 30 and 50 years while 25 (56%) ministers have declared their age to be between 51 and 70 years.
- **Women Ministers:** Out of 45 ministers analysed, 5(11%) are women.

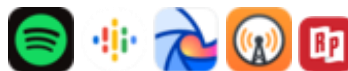
