Summary and Highlights



Criminal Background

- <u>Candidates with Criminal Cases</u>: Out of 79 candidates analyzed, **20 (25%)** candidates have declared criminal cases against themselves.
- <u>Candidates with Serious Criminal Cases</u>: 18(23%) candidates have declared serious criminal cases against themselves.
- <u>Candidates with cases related to Murder</u>: 1 candidate has declared cases related to murder (IPC Section -302) against himself.
- <u>Candidates with cases related to Attempt to Murder</u>: 3 candidates have declared cases related to attempt to murder (IPC Section 307) against themselves.
- <u>Candidates with cases related to Crime Against Women:</u> 7 candidates have declared cases related to crime against women. Out of 7 candidates 1 candidate has declared cases related to rape (IPC Section-376).



- 2. If an offence is non-bailable
- If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- 5. Offences that are assault, murder, kidnap, rape related
- Offences that are mentioned in Representation of the People Act (Section 8)
- 7. Offences under Prevention of Corruption Act
- 8. Crimes against women.
