Criminal Background

- <u>Candidates with Criminal Cases:</u> Out of 57 candidates analyzed, **13 (23%)** candidates have declared criminal cases against themselves.
- <u>Candidates with Serious Criminal Cases:</u> **12(21%) candidates** have declared serious criminal cases against themselves.

- 1. Offence for which maximum punishment is of 5 years or more.
- 2. If an offence is non-bailable
- If it is an electoral offence (for eg. IPC 171E or bribery)
- 4. Offence related to loss to exchequer
- 5. Offences that are assault, murder, kidnap, rape related
- 6. Offences that are mentioned in Representation of the People Act (Section 8)
- Offences under Prevention of Corruption Act
- 8. Crimes against women.
