## Summary and Highlights

Association for Democratic Reforms (ADR) and Maharashtra Election Watch have analysed the self-sworn affidavits of **98** out of **102** winners in the Solapur Municipal Corporation Elections 2017

*Criteria for serious criminal cases*

1. Offence for which maximum punishment is of 5 years or more.
2. If an offence is non-bailable
3. If it is an electoral offence (for eg. IPC 171E or bribery)
4. Offence related to loss to exchequer
5. Offences that are assault, murder, kidnap, rape related
6. Offences that are mentioned in Representation of the People Act (Section 8)
7. Offences under Prevention of Corruption Act
8. Crimes against women.

## Criminal Background

- **Winners with Criminal Cases:** **23 (23%)** out of **98** analyzed winners have declared criminal cases against themselves.
- **Winners with Serious Criminal Cases:** **14 (14%)** out of **98** analyzed winners have declared serious criminal cases against themselves like **murder, attempt to murder, crime against women, kidnapping, criminal intimidation, house-trespass, cheating and dishonestly inducing delivery of property, etc.**

- Party wise winners with declared Criminal Cases:** 10 (21%) out of 47 winners analysed from **BJP**, 5 (25%) out of 20 winners analysed from **SHS**, 3 (23%) out of 13 winners analysed from **INC**, 2 (22%) out of 9 winners analysed from **AIMIM**, 2 (50%) out of 4 winners analysed from **NCP** and 1 (25%) out of 4 winners analysed from **BSP** have declared **criminal cases** against themselves in their affidavits.
- Party wise winners with declared Serious Criminal Cases:** 5 (11%) out of 47 winners analysed from **BJP**, 4 (20%) out of 20 winners analysed from **SHS**, 2 (50%) out of 4 winners analysed from **NCP**, 1 (25%) out of 4 winners analysed from **BSP**, 1 (11%) out of 9 winners analysed from **AIMIM** and 1 (8%) out of 13 winners analysed from **INC** have declared **serious criminal cases** against themselves in their affidavits.
