Meghalaya 2008 Assembly Elections

Meghalaya Assembly Elections, 2008 were held during the month of March, 2008. This report includes the analysis of criminal, financial, educational background and other details of the candidates and winners of these elections. Information provided by the Election Commission of India and details from the affidavits filed by the candidates have been used for the analysis.

Growth of political parties

In the 2003 Meghalaya Assembly Elections, 13 political parties contested which decreased to 10 in the 2008 Meghalaya Assembly Elections. This reflects a decrease of 23% in the number of political parties that contested, from the Meghalaya 2003 Assembly Elections to the Meghalaya 2008 Assembly Elections.

Executive summary of candidates and MLAs

Summary of Candidates

- Meghalaya Election Watch (REW) analyzed affidavits of 234 candidates out of 331 who contested in the 2008 Assembly elections.
- Out of these 234 candidates analyzed, 2 (1%) candidates have declared criminal cases against them. NCP has 1 out of 45 (2%), the second candidate is an Independent.
- Out of these 2 candidates with declared criminal cases, 2 (100%) have pending serious criminal cases like murder, attempt to murder, kidnapping, extortion etc. INC has 6, BJP has 3, BSP has 3 and CPM has 1 candidate with serious criminal cases declared against them.
- There are 2 IPC charges of Sedition and Theft.
- A total of 25 candidates out of 234 analyzed i.e. 11% are crorepatis.
- A total of 17 candidates out of 234 analyzed, have declared liabilities of Rs 5 lakhs or above.
- Among major parties, the average asset per candidate for INC is Rs. 70 Lacs, for BJP it is 9 Lacs and for UDP it is 91 Lacs.
- 95% of candidates (223 out of 234 analyzed) have not furnished PAN card details.
- Number of women candidates is 8 (3%) as compared to 226 of men (97%) out of 234 candidates analyzed.
- More than 63% of candidates (14 of 234 analyzed) are graduates or with higher educational qualification.

Summary of MLAs

- Affidavits of 58 MLAs out of 60 MLAs were analyzed by MEW.
- Out of 58 MLAs analyzed 1 (2%) has declared criminal cases against himself. NCP has 1 out of 13 (16%) MLAs who have declared criminal cases against themselves.

- 1 MLA from NCP has declared a serious criminal case against himself.
- Out of 15 (26% of 58 analyzed) crorepati MLAs in 2008 Meghalaya Assembly, 4 are from UDP, 8 are from INC, 2 from NCP, 1 is independent.
- Average asset for an MLA from Meghalaya is Rs 1.88 crores.
- Among major parties, the average asset per MLA for BSP is Rs 3.44 crores, for BJP and for INC is Rs. 1.66 crores.
- Out of 58 MLAs analyzed, 53 MLAs have not declared their PAN details.
- Out of 58 MLAs analyzed, only 1 is a woman. Hence only 1.72% of MLAs in current Meghalaya assembly are women.

Analysis based on declared criminal cases- candidates

Affidavits of 234 candidates were analyzed by Meghalaya Election Watch (REW) for 2008 Assembly elections. Out of the 234 candidates, 76 or 32% declared criminal cases against them. Out of these 32 candidates with declared criminal cases, 2 had serious criminal cases like murder, attempt to murder, kidnapping, extortion, etc. declared against them.

Party-wise break up of candidates with pending criminal cases

A total of 2 candidates contesting elections out of the 76 analyzed from Meghalaya have declared criminal cases against them. Out of 45 candidates of NCP, 1 (2%) has declared criminal cases against himself, and out of 31 independent candidates, 1 (3%) has declared criminal cases against himself.






